THIS MEASURE IS THE ACT PASSED BY THE TWENTY-FIFTH LEGISLATIVE ASSEMBLY IN 1937 AS HOUSE BILL NO. 196 REGULATING, LICENSING AND AUTHORIZING THE SALE OF LIQUOR AT RETAIL FOR CONSUMPTION ON THE PREMISES WHERE SOLD; PROVIDING FOR A LICENSE TAX, LICENSE FEES AND FOR AN EXCISE TAX ON LIQUOR; ALLOCATING THE REVENUE TO BE DERIVED FROM SAID LICENSES AND EXCISE TAXES; PROVIDING FOR LOCAL OPTION IN COUNTIES, AND FOR PENALTIES; REPEALING ACTS AND PARTS OF ACTS IN CONFLICT WITH THIS ACT; AND CONTAINING OTHER PROVISIONS RELEVANT TO THESE.

A BILL PROPOSING BY INITIATIVE A LAW KNOWN AS THE STATE HIGHWAY TREASURY ANTICIPATION DEBENTURES ACT: AUTHORIZING ISSUANCE OF DEBENTURES IN THE SUM OF \$3,000,000; PROVIDING FOR THEIR SALE AND USE OF PROCEEDS IN MATCHING FEDERAL HIGHWAY GRANTS; PROVIDING FOR CONTINUATION OF PRESENT GASOLINE TAX OF 5c PER GALLON; PLEDGING THE PROCEEDS FOR REPAYMENT OF THE DEBENTURES ISSUED; BINDING THE STATE OF MONTANA NOT TO REDUCE SUCH GASOLINE TAX UNTIL SUFFICIENT MONEY HAS BEEN RECEIVED TO PAY THE PRINCIPAL AND INTEREST ON SUCH DEBENTURES, PROHIBITING DIVERSION OF THE PROCEEDS OF SUCH TAX FOR OTHER THAN HIGHWAY PURPOSES.
