 AN ACT AUTHORIZING AN INDEBTEDNESS OF THE STATE OF MONTANA OF SIX HUNDRED NINETY THOUSAND DOLLARS (\$690,000.00) IN EXCESS OF THE CONSTITUTIONAL DEBT LIMITATION AND OVER AND ABOVE EXISTING BONDED INDEBTEDNESS FOR WHICH THE STATE IS NOW OBLIGATED, FOR THE CONSTRUCTION, REPAIR, REMODELING AND EQUIPPING OF NECESSARY BUILDINGS AT MONTANA STATE COLLEGE AT BOZEMAN, MONTANA; AUTHORIZING THE ISSUANCE AND SALE OF BONDS IN THE NAME OF THE STATE AS EVIDENCE OF SUCH INDEBTEDNESS, PRESCRIBING THE FORM OF SUCH BONDS AND PROVIDING FOR AN ANNUAL TAX SUFFICIENT TO PAY THE PRINCIPAL THEREOF AND THE INTEREST ACCRUING THEREON, AND FOR A REFERENDUM HEREOF.
