PROPOSED PETITION FOR INITIATIVE NO. 54

A BILL PROVIDING FOR THE PAYMENT OF AN HONORARIUM, OR ADJUSTED COMPENSATION, TO EACH RESIDENT OF MONTANA ON ACTIVE DUTY IN THE MILITARY FORCES OF THE UNITED STATES DURING WORLD WAR II; AUTHORIZING THE STATE OF MONTANA TO BECOME INDEBTED IN THE SUM OF TWENTY-TWO MILLION DOLLARS (\$22,000,000.00) IN EXCESS OF THE CONSTITUTIONAL LIMIT; CREATING THE WAR VETERANS' COMPENSATION FUND; PROVIDING FOR THE ISSUANCE OF BONDS; PROVIDING THAT SUCH BONDS SHALL NOT BECOME GENERAL OBLIGATION BONDS OF THE STATE OF MONTANA; PROVIDING FOR AN EXCISE TAX UPON CIGARETTES.
