CONSTITUTIONAL AMENDMENT

AN ACT TO SUBMIT TO THE QUALIFIED ELECTORS OF THE STATE OF MONTANA, AN AMENDMENT TO SECTION 9 OF ARTICLE VII OF THE CONSTITUTION OF THE STATE OF MONTANA, RELATING TO THE POWER OF THE GOVERNOR TO GRANT PARDONS, TO REMIT FINES AND FORFEITURES, TO GRANT COMMUTATION OF PUNISHMENT AND RESPITES AFTER CONVICTION AND JUDGMENT FOR ANY OFFENSES COMMITTED AGAINST THE CRIMINAL LAWS OF THE STATE; PROVIDING, THAT BEFORE GRANTING PARDONS, REMITTING FINES AND FORFEITURES OR COMMUTING PUNISHMENTS, THAT THE ACTION OF THE GOVERNOR CONCERNING THE SAME SHALL BE TAKEN UPON THE ADVICE OF A BOARD, OR A MAJORITY THEREOF, WHO SHALL BE KNOWN AS THE BOARD OF PARDONS; AND PROVIDING THAT THE LEGISLATIVE ASSEMBLY, SHALL BY LAW, PRESCRIBE FOR THE APPOINTMENT AND COMPOSITION OF SAID BOARD OF PARDONS, ITS POWERS AND DUTIES; AND TO REGULATE THE PROCEEDINGS THEREOF.

REFERENDUM MEASURE NO. 56

AN ACT PROVIDING FOR THE EXPRESSION BY THE PEOPLE OF THE STATE OF MONTANA OF THEIR PREFERENCE FOR PARTY NOMINATIONS FOR PRESIDENT OF THE UNITED STATES; PROVIDING FOR THE ELECTION OF DELEGATES AND ALTERNATES TO NATIONAL CONVENTIONS OF POLITICAL PARTIES; PROVIDING FOR THE METHOD OF HOLDING PRESIDENTIAL PRIMARIES; AMENDING SECTION 23-1002 OF THE REVISED CODES OF MONTANA, 1947, RELATING TO THE METHOD OF SELECTING DELEGATES TO NATIONAL POLITICAL CONVENTIONS; AMENDING SECTION 23-1006 OF THE REVISED CODES OF MONTANA, 1947, RELATING TO THE ELECTION OF PRESIDENTIAL DELEGATES AND ALTERNATES TO THE NATIONAL CONVENTIONS; AMENDING SECTION 23-1007 OF THE REVISED CODES OF MONTANA, 1947, RELATING TO THE CERTIFICATION OF THE ELECTION OF DELEGATES TO THE NATIONAL CONVENTIONS; AMENDING SECTION 23-1008 OF THE REVISED CODES OF MONTANA, 1947, RELATING TO PAYMENT OF CONVENTION EXPENSES; AMENDING SECTION 23-902 OF THE REVISED CODES OF MONTANA, 1947, RELATING TO THE DATE OF HOLDING PRIMARY ELECTIONS; PROVIDING FOR THE SUBMISSION OF THIS ACT TO THE QUALIFIED ELECTORS OF THE STATE OF MONTANA AT THE NEXT GENERAL ELECTION; DESCRIBING THE FORM OF BALLOTS TO BE USED AND THE DUTIES OF SECRETARY OF STATE OF THE STATE OF MONTANA RELATIVE TO THE SUBMISSION OF SAID ACT TO THE QUALIFIED ELECTORS OF SAID STATE; PROVIDING WHEN THIS ACT SHALL TAKE EFFECT; AND PROVIDING FOR REPEAL OF ALL OTHER ACTS AND PARTS OF ACTS IN CONFLICT HEREWITH UPON APPROVAL OF THIS ACT BY MAJORITY OF ALL VOTES CAST AT THE REFERENDUM ELECTION HEREIN PROVIDED.
