AN ACT TO AUTHORIZE THE STATE OF MONTANA TO BECOME INDEBTED FOR THE SUM OF ONE MILLION FIVE HUNDRED THOUSAND DOLLARS (\$1,500,000.00) IN EXCESS OF THE CONSTITUTIONAL LIMITATION OF INDEBTEDNESS AND OVER AND ABOVE ANY BONDED INDEBTEDNESS HERETOFORE INCURRED OR CREATED AND FOR WHICH THE STATE OF MONTANA IS NOW OBLIGATED, FOR THE CONSTRUCTION AND EQUIPMENT OF NECESSARY BUILDINGS AND OTHER PERMANENT IMPROVEMENTS AND THE ACQUISITION OF NECESSARY GROUNDS THEREFOR FOR THE MONTANA STATE TRAINIG SCHOOL AT BOULDER, MONTANA, AND THE ACQUISITION OF FARM LANDS TO BE USED IN CONNECTION THEREWITH AND FOR THE SUPPORT THEREOF; PROVIDING FOR THE ISSUANCE OF BONDS IN THE NAME OF THE STATE OF MONTANA AS EVIDENCE OF SUCH INDEBTEDNESS AND FOR THE SALE THEREOF; PRESCRIBING THE FORM OF SUCH BONDS AND PROVIDING FOR A LEVY OF AN ANNUAL TAX SUFFICIENT TO PAY THE PRINCIPAL THEREOF AND THE INTEREST ACCRUING THEREON; AND PROVIDING FOR A REFERENDUM OF THIS ACT.
