PROPOSITION
 THAT THE BOARD OF GALLATIN COUNTY COMMISSIONERS BE AUTHORIZED TO MAKE A LEVY OF ELEVEN (11) MILLS IN ADDITION TO THE MILL LEVY LIMIT IMPOSED BY LAW FOR THE PURPOSE OF FUNDING OPERATIONS AND CAPITAL EXPENDITURES FOR GALLATIN COUNTY'S EMERGENCY COMMUNICATIONS AND RECORDS FUNCTIONS.

THE SPECIFIC AMOUNT OF MONEY THAT IS TO BE RAISED, BASED ON GALLATIN COUNTY FISCAL YEAR 2001 MILL RATE, IS \$1,295,756. THE LEVY SHALL BE IN PERPETUITY, PROVIDED THAT, THE GALLATIN COUNTY COMMISSION MAY DETERMINE IN A SPECIFIC FUTURE FISCAL YEAR THAT THE NUMBER OF MILLS REQUIRED SHOULD BE LOWERED.
