Proposition No. 3 - Bonded Indebtedness

If the first proposition is adopted, shall the Four Corners County Water and Sewer District be authorized to incur bonded indebtedness in the principal amount of \$9,500,000 or such lesser amount as is necessary and maturing over a term of not to exceed twenty (20) years, for the purpose of acquiring, constructing, furnishing, and equipping a municipal drinking water and a wastewater treatment facility with the capacity to serve the District and to pay the costs of installing water and sanitary sewer trunks, mains and lateral lines and related appurtenances as required to connect the subdivisions to the central system?

Shall the qualified voters of the Willow Creek Rural Fire District authorize the Board of Trustees of the Willow Creek Rural Fire District to approve an increase in the annual levy of up to, but not to exceed, 9.8 mills or \$10,365.00, whichever is greater (but not including property which becomes "newly taxable property" after December 31, 2001) for the essential services provide by the Willow Creek Rural Fire District; the increase would be 9.8 mills or \$10,365.00 whichever is greater, above the property tax limitations of Sections 15-10-401 and 402, MCA. The levy increase would be used to acquire a structure fire engine, replace personal protective equipment for fire fighters and provide for increased operational costs.
