The following Proclamation was approved:

A PROCLAMATION BY THE COMMISSIONERS OF GALLATIN COUNTY, MONTANA

By virtue of the authority vested in the Commissioners of Gallatin County, Montana, by the Constitution and Section 16-5115.13 (2), Revised Codes of Montana, 1947. We, Walter R. Sales, George W. Sager and George R. Gillette do hereby proclaim that on Tuesday, the 8th day of February, 1977, there will be in the County of Gallatin, State of Montana, a Special Primary Election by the qualified electors of said County to vote for a County Commissioner, District No. 3, Clerk of the District Court, County Attorney, and for any other Office that may become vacant.

And in order that the election be conducted in a quiet and orderly manner. We do hereby offer a reward of One Hundred Dollars (\$100.00) for arrest and conviction of any person violating any of the provisions of Section 23-4701 through 23-4724, Revised Codes of Montana, 1947, such rewards to be paid until the total amount hereafter expended for the purpose reaches the sum of Five Thousand Dollars (\$5,000.00).
