Petition For Road.

To The Hon. Board of County Commissioners, of Gallatin County, Mont.:

The Undersigned, Your petitioners, Citizens of the United States, respectfully show and represent that they are residents of and freeholders in Road District No. 4, in the County of Gallatin, State of Montana, and taxable therein for road purposes, where the road, hereafter petitioned for, is to be located, laid out and established, if this petition be granted; that the proposed road is a public convenience, and, we think, the public good requires it.

Your petitioners do respectfully ask and petition that a County Road 40 feet in width, to be a public highway, to be laid out, located and established.

And show:

- (a) The general route of the proposed road.
- (b) Over what lands it is proposed to be established.
- (c) Who are the owners thereof.
- (d) Whether such of them as can be found, consent thereto.
- (e) Who of them do not consent.
- (f) The probable cost of such right-of-way where such consent is not had.
- (g) The necessity for and advantages of the proposed road as follows, to-wit:

Beginning at the S. E. Cor. of Sec. 9, T.3 S. R.5 E., said point being in the County Road; thence west along the Sec. line a distance of two miles between Sections 8 & 9 on the North and 16 & 17 on the South and intersecting with the said County Road at the S. W. Cor. of said Sec. 8.

C The land is owned as follows:-

Chas. Anderson owns the S. 1/2 of Sec. 9 and the E. 1/2 of the N.W. 1/4 and the N.E. 1/4 of Sec. 16

Mrs. M.E. Kent owns the W. 1/2 of the N.W. 1/4 of Sec. 16.

Irvin Kent owns the S.E. 1/4 of Sec. 8 and a 20 acre strip off the North side of the N.E. 1/4 of Sec. 17.

Mrs. L. E. Godson owns S.W. 1/4 of Sec. 8.

Walter Buzard owns the N.W. 1/4 of Sec. 17.

(D) Mrs. M. E. Kent, Irvin Kent + Mrs. L. E. Godson

(E) Chas. Anderson and Walter Buzard.

(F) 600⁰⁰ (Approximately)

(G) Shortening the distance to Salesville from Middle Creek and a great convenience to your petitioners.
