CHANGE OF
Petition For Road:

To The Hon. Board of County Commissioners, of Gallatin County, Mont.:

The Undersigned, Your petitioners, Citizens of the United States, respectfully show and represent that they are residents of and freeholders in Road District No. 8, in the County of Gallatin, State of Montana, and taxable therein for road purposes, where the road, hereafter petitioned for, is to be located, laid out and established, if this petition be granted; that the proposed ^{CHANGE OR} road is a public convenience, and, we think, the public good requires it.

Your petitioners do respectfully ask and petition that a ^{CHANGE IN A} County Road 50 feet in width, to be a public highway, to be laid out, located and established.

And show:

- (a) The general route of the proposed road.
- (b) Over what lands it is proposed to be established.
- (c) Who are the owners thereof.
- (d) Whether such of them as can be found, consent thereto.
- (e) Who of them do not consent.
- (f) The probable cost of such right-of-way where such consent is not had.
- (g) The necessity for and advantages of the proposed road as follows, to-wit:

Beginning at a point in the west line of the S.W. 1/4 of Section 29, T.1 S., R.4 E. in the County Road known as the Davidson Road, said point being 25 feet north of the north side of the West Gallatin Irrigation Cos. Canal; Thence southerly along the east side of said canal to the southwest corner of said section; Thence south along the west line of section 32 crossing said canal, to sta. 228 2x28 of the County Road known as the Whittaker Road No. 194.

That portion of the present County Road between the starting point and terminus of the above described change to be vacated and discontinued whenever the change herein petitioned for is established.

- (c) The land over which the proposee change runs is owned by Mr. K. Schuling who asks for the change.
- (f) The object of the change is to avoid one bridge across the canal.
