Petition for Road.

To The Hon. Board of County Commissioners, of Gallatin County, Mont.:

THE UNDERSIGNED, Your petitioners, Citizens of the United States, respectfully show and represent that they are residents of and freeholders in Road District No....., in the County of Gallatin, State of Montana, and taxable therein for road purposes, where the road, hereinafter petitioned for, is to be located, laid out and established, if this petition be granted; that the proposed road is a public convenience, and, we think, the public good requires it.

Your petitioners do respectfully ask and petition that a County Road ¹⁴ 24 or 60 feet ^{to} Grade feet in width, to be a public highway, to be laid out, located and established.

And show

- (a) The general route of the proposed road.
- (b) Over what lands it is proposed to be established.
- (c) Who are the owners thereof.
- (d) Whether such of them as can be found, consent thereto.
- (e) Who of them do not consent.
- (f) The probable cost of such right-of-way where such consent is not had.
- (g) The necessity for and advantages of the proposed road as follows, to-wit:

Starting and beginning at a Point in the South West of Sec 31 connecting with the Belgrade or Conformer Road in Town 1 R 4 E and Running up Foster Creek in a North easterly Course through Sec 31-30-29-21- to a Point in Sec 21 connecting with the Conner Road leading to the Flat Head Pass and Country giving and outlet to a number of Ranchers to Belgrade their Shipping Point

The owners of the above lands are Saul Miller, J. M. Huffer, Wm. Huffine, J. M. Vasier, Chris Miller and S. H. Carson who all agree to give a Free Right of way for a Twenty ft Road with 20 ft Grade
