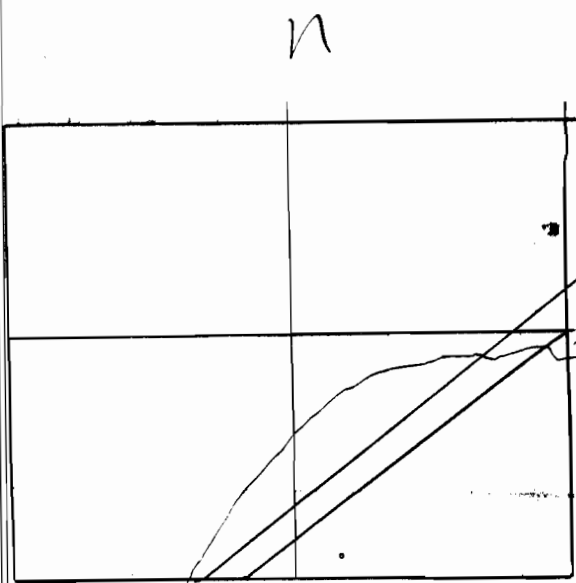

PETITION FOR CHANGE OF ROAD.

We, the undersigned, residents of road district No., of Gallatin County, Montana, hereby petition that the public highway running in a Northeasterly direction across the South half of Section 13, Township 1 South, Range 5 East, be changed by setting the same back in a Westerly direction a distance of about 250 feet throughout said distance across said Section, as shown by the attached exhibit marked "Exhibit A". The reasons for the proposed change is that by moving the road back the proposed distance it will be located along the foot hills and will make a more substantial road-bed than the present.

It will also enable Lyman Walton, who owns the Southeast quarter of said Section 13, to cultivate quite a large area of land which can not now be successfully cultivated on account of the location of said road.
