Petition for Road

To The Hon. Board of County Commissioners, of Gallatin County, Mont.:

THE UNDERSIGNED, Your petitioners, Citizens of the United States, respectfully show and represent that they are residents and freeholders in Road District No. 12, in the County of Gallatin, State of Montana, and taxable therein for road purposes, when the road, hereinafter petitioned for, is to be located, laid out and established, if this petition be granted; that the proposed road is a public convenience, and, we think, the public good requires it.

Your petitioners do respectfully ask and petition that a County Road 40 feet in width, to be a public highway, to be laid out, located and established.

And show

- (a) The general route of the proposed road.
- (b) Over what lands it is proposed to be established.
- (c) Who are the owners thereof.
- (d) Whether such of them as can be found, consent thereto.
- (e) Who of them do not consent.
- (f) The probable cost of such right-of-way where such consent is not had.
- (g) The necessity for and advantages of the proposed road as follows, to-wit:

(a) Beginning at the N.W. corner of section 7, T. 22S, R. R3 E. thence East to the N.E. corner of section 8, same township and range thence East about one quarter of a mile thence in a north easterly direction along a ^{draw to the} present County Road, on a line to be hereafter designated by Webb Vincent, the owner of said Sec 4.

(b) Sections 7, 6, 5, 8 and 4 all in township two south range three east.

(c) Ed Scanlon, E. J. Parkins, Berthot & Truitt, E. M. Cummings and Webb Vincent.

(d) All consent.

(e) Not any.

(f) No cost to Gallatin County.

(g) To give an outlet for the residents of this section of country to market their products and to enable children to reach the School House.

The within Petition is granted, with the exception of the West mile: that is beginning at the NW cor of sec 7.
