Petition for Road

To The Hon. Board of County Commissioners, of Gallatin County, Mont.:

THE UNDERSIGNED, Your petitioners, Citizens of the United States, respectfully show and represent that they are residents and freeholders in Road District No. 11, in the County of Gallatin, State of Montana, and taxable therein for road purposes, when the road, hereinafter petitioned for, is to be located, laid out and established, if this petition be granted; that the proposed road is a public convenience, and, we think, the public good requires it.

Your petitioners do respectfully ask and petition that a County Road forty feet in width, to be a public highway, to be laid out, located and established,

And show

- (a) The general route of the proposed road.
- (b) Over what lands it is proposed to be established.
- (c) Who are the owners thereof.
- (d) Whether such of them as can be found, consent thereto.
- (e) Who of them do not consent.
- (f) The probable cost of such right-of-way where such consent is not had.
- (g) The necessity for and advantages of the proposed road as follows, to-wit:

(a) ~~Beginnin~~ where the present County Road crosses the west line of the east half of section eleven, township one south, range one west; thence in a south westerly direction through the west half of sections 11 and 14 same township and range to the south west corner of said section 11; thence west along the south line of section fifteen same township and range to the south west corner thereof.

(b) Sections 11, 14, 15, 22, township one south range one west.

(c) Section 11, Walter H. Mack. Section 14, Lamoni Howls and Willis Albro. Section 15, A. Girard, Section 22, Fred Bouvier.

(d) All consent except Lamoni Howles.

(f)

(g) To close the present County Road beginning ^{ewhere} ~~at~~ the proposed new road ^{road} leaves the present road and extending westerly to the County Line.

The advantage of closing said road being to keep range cattle out of the farming district, to avoid the present heavy grade over the big hill and to provide a better road for travel in general and to open up the Galen Springs settlement.
