# Petition for Road

To The Hon. Board of County Commissioners, of Gallatin County, Mont.:

THE UNDERSIGNED, Your petitioners, Citizens of the United States, respectfully show and represent that they are residents and freeholders in Road District No. Eleven, in the County of Gallatin, State of Montana, and taxable therein for road purposes, when the road, hereinafter petitioned for, is to be located, laid out and established, if this petition be granted; that the proposed road is a public convenience, and, we think, the public good requires it.

Your petitioners do respectfully ask and petition that a County Road Forty feet in width, to be a public highway, to be laid out, located and established. as described below

And show **the necessity of said road being established**

- (a) The general route of the proposed road. South West
- (b) Over what lands it is proposed to be established. Section Ten
- (c) Who are the owners thereof. W H Oack - Lamou. Hawks wa-albro J J Murphy Jany Girard Fred Bowler
- (d) Whether such of them as can be found, consent thereto.
- (e) Who of them do not consent. W.H. Oack
- (f) The probable cost of such right-of-way where such consent is not had.
- (g) The necessity for and advantages of the proposed road as follows, to-wit:

~~(a) Beginning at a point on the County Road one Fourth mile North of of the south East corner of Section Ten Township (1) One South of range (1) One West M.P.M. and Running due south along the section line between sections Ten and Eleven - and Fourteen and Fifteen to Madison County line A distance of one and one fourth mile and thence running due West along County line one Mile to the South East Corner of Section Sixteen Same Township and range and Intersects with the Present County road~~

(g) It is an absolute necessity for an outlet for Nine residents who is now shut in from the county road all of who is at the mercy of thier neighbors to allow them the privelege of traveling through thier land bisides opening and shutting several gates. which is very disagreeable to all concerned
