# Petition for Road

435

To The Hon. Board of County Commissioners, of Gallatin County, Mont.:

THE UNDERSIGNED, Your petitioners, Citizens of the United States, respectfully show and represent that they are residents and freeholders in Road District No. 4, in the County of Gallatin, State of Montana, and taxable therein for road purposes, when the road, hereinafter petitioned for, is to be located, laid out and established, if this petition be granted; that the proposed road is a public convenience, and, we think, the public good requires it.

Your petitioners do respectfully ask and petition that a County Road.....feet in width, to be a public highway, to be laid out, located and established.

And show

- (a) The general route of the proposed road.
- (b) Over what lands it is proposed to be established.
- (c) Who are the owners thereof.
- (d) Whether such of them as can be found, consent thereto.
- (e) Who of them do not consent.
- (f) The probable cost of such right-of-way where such consent is not had.
- (g) The necessity for and advantages of the proposed road as follows, to-wit:

We petition your honorable body to grant the petitioners the privilege of changing a portion of the County road in Sec 22 T46S R4E from its present uncertain location to the following line. Beginning at a point about 200 ft NE of SE cor of NE 1/4 of Sec 22. Running thence S 27 1/2° W about 2200 ft to again join the present road. The Petitioner ~~will~~ to remove all brush etc and make road ~~equally~~ as good or better than present road. This will change the road about 200 ft on an average and will allow cultivation and improve much not at present possible under existing conditions. Exact location and distances will be furnished County Surveyor as soon as Gov Survey of Montana is made.
