PETITION FOR ROAD

NO. 577

To the Honorable Board of County Commissioners of Gallatin County, Montana:

Gentlemen:

We the undersigned freeholders of Road District No. 5 of Gallatin County, taxable therein for road purposes, do hereby petition your honorable body to establish same as a County Road, beginning at a point on U.S. No. 10 Highway just west of Mt. Ellis Station in the N.E. $\frac{1}{4}$ of Section 23, T. 2 S., R. 6 E., thence following the route of the present travelled road northeasterly for a distance of approximately $\frac{1}{4}$ mile to a point on said road located 30 feet north of the south line of the one acre tract owned by Lee Murphy; said road to have a right of way 40 feet in width.
