Gentlemen:

We, the undersigned freeholders (of Road District No. \_\_\_\_\_),

petition your Honorable Body to establish as a County Road the

Southeast Quarter (SE $\frac{1}{4}$ ) of Section Thirteen  
(13) of Township One (1) South, Range Five (5)  
East, where the trail road from Sipes Canyon  
joins said Road No. 361, thence Northeasterly  
along the Sipes Canyon Trail Road a distance  
of approximately 2.0 miles to the mouth of  
Sipes Canyon in the East half of Section Seven-  
teen (17) of Township One (1) South, Range Six  
(6) East.
