As Acting County Surveyor viewing Roads No. 170 No. 483 and part of No. 214 at the request of the County Commissioners of Gallatin County on Nov. 11th 1953, 1/6-4 make the following Comments:

went over the road in Border's jeep. We left the Dry Creek Road and entered on road No 170, in Section 20 T 2 N R 4 E, then on Road No. 483 in Section 35 and 34, T 3 N R 4 E; Indicated the road has had very little travel on it for approximately one and one half miles; From there on it showed more travel, some of which was farm machinery, as there is a stubble field on the west side of the road in question. Continueing on north across the County Road which runs west from Menard, we enter on road No. 214; this also showed very little sign of travel all the way untill you get to the Northwest corner of Section 22, T 3 N. R 4 E.

In regard to fences, referring to the map, there was a gate as you go into Section 35 and as you leave Section 35. The rest of the way fences were down and wire scattered over the ground, except on the North where the read is adjacent to Border's and Durhams land in Section 22.

At no place along this route has there been any County Road maintenance for a number of years. There are no bridges or culverts in useable condition, except a stock pass between Sections 2 and 35.

WHEREAS, if these roads were to be left open it could be a terrific, unnecessary expense to the County to put same in shape to be traveled by modern vehicles; and


WHEREAS, there was no evidence to show or prove that these roads have been maintained as public roads for many years,
