PETITION TO ABANDON ROAD

To the Honorable Board of
County Commissioners of
Gallatin County, Montana.

Gentlemen:

We, the undersigned freeholders of Gallatin
County, do hereby petition your Honorable body to
abandon as a public highway, the following described
County Road:

That portion of the old Grayling Creek to
Hebgen Dam road, more particularly described as follows:

Beginning at a point on the east line of
Section 8, Township 12 South, Range 5 East, said
point being 605.0 feet, more or less, north of
the southeast corner of said Section 8; thence
from said point of beginning in a northwesterly direction
along the said Grayling Creek to Hebgen Dam road,
which was deeded by The Montana Reservoir and
Irrigation Co. to Gallatin County and recorded
in Book 67 of Deeds, page 273, thru the south
half of Section 8 and the southeast quarter of
Section 7 and the west half of Section 7, said
Township and Range, to a point where said road
joins State Highway No. 1, at a point approx-
imately 1020 feet east of the west quarter section
corner of said Section 7, T. 12 S., R. 5 E.



That portion of the old Grayling Creek to Hebgen Dam road, more particularly described as follows:

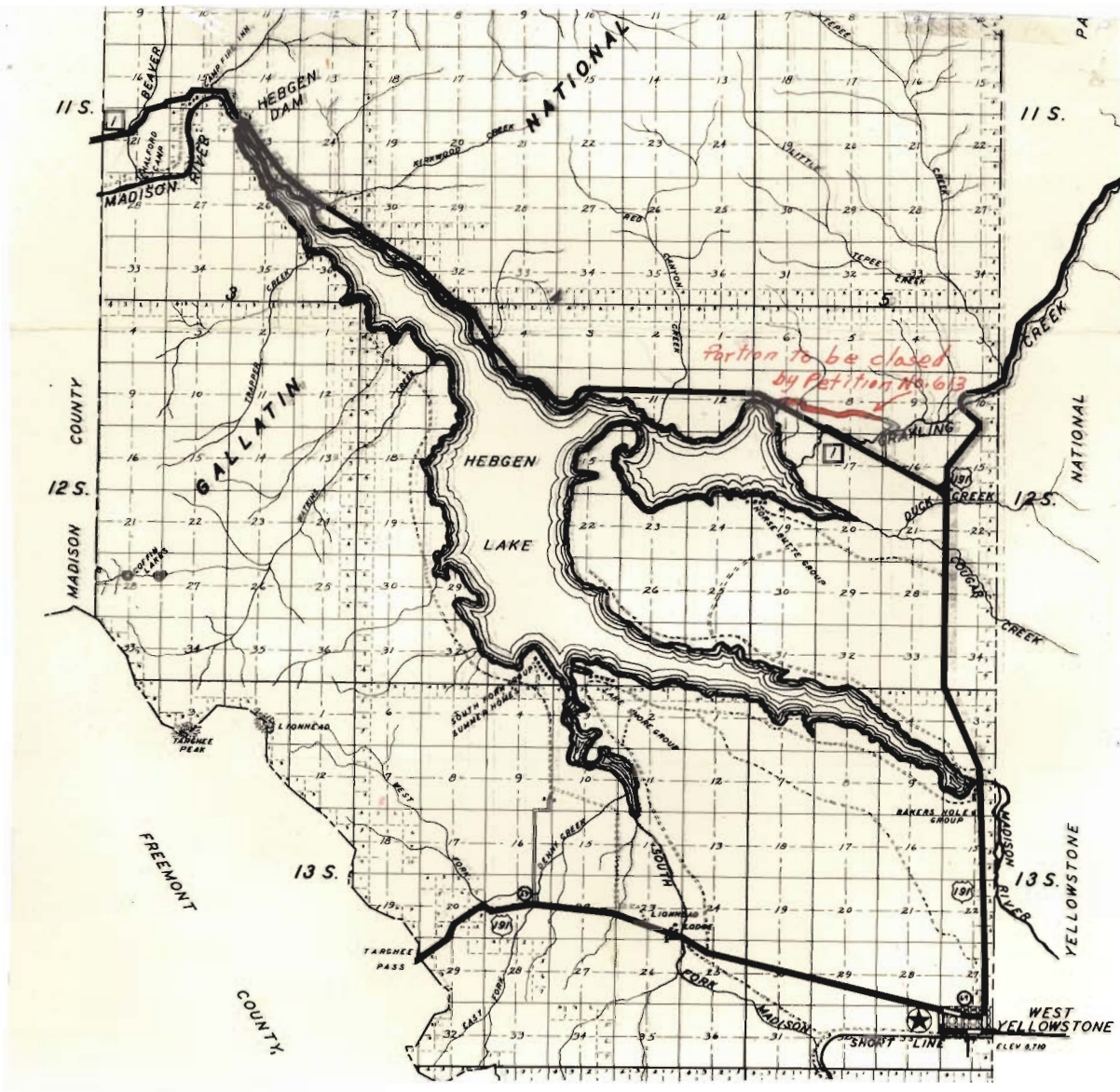
Beginning at a point on the east line of Section 8, Township 12 South, Range 5 East, said point being 605.0 feet, more or less, north of the southeast corner of said Section 8; thence from said point of beginning in a northwesterly direction along the said Grayling Creek to Hebgen Dam road, which was deeded by The Montana Reservoir and Irrigation Company to Gallatin County and recorded in Book 67 of Deeds, page 273, thru the south half of Section 8 and the southeast quarter of Section 7 and the west half of Section 7, said Township and Range, to a point where said road joins State Highway No. 1, at a point approximately 1,020 feet east of the west quarter section corner of said Section 7, T. 12 S., R. 5E.
