That when the new highway is completed the road described in Petition No. 615 can be closed because it will be of no use to anyone, and Gallatin County does not care to maintain an unnecessary road;

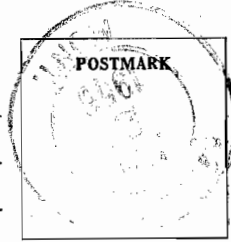
Therefore we recommend that the road as described in said Petition be vacated and closed.
