PETITION TO ABANDON ROAD

To the Honorable Board of
County Commissioners
Gallatin County, Montana

Gentlemen:

We, the undersigned freeholders of Gallatin County, Montana, taxable therein for road purposes, do hereby petition your Honorable body to abandon as a public highway, the following described County road:

That portion of County Road No. 91, known as Lincoln road, said road being 30 feet wide, and lying south of the East and West center line of Section 13, T. 2S., R. 5E. M.P.M. which is also the line of the City Limits of Bozeman, and being more particularly described as follows:

Beginning at the center of Section 13, T.2S., R. 5E., at the southerly end of Eleventh Avenue, extended: Thence from said center of Section due east 2,010 feet, more or less, to a point which is due south of the west line of Sixth Avenue South.

That portion of County Road No. 91, known as Lincoln Road, said road being 30 feet wide, and lying south of the east and west center line of Section 13, T. 2S., R. 5E., M.P.M., which is also the line of the City Limits of Bozeman, and being more particularly described as follows:

Beginning at the center of Section 13, T. 2S., R. 5E., at the southerly end of Eleventh Avenue, extended; Thence from said center of Section due east 2,010 feet, more or less, to a point which is due south of the west line of Sixth Avenue South.

A hearing on the above matter has been set by the Board of County Commissioners for Wednesday, February 1, 1956, at 2:00 o'clock P. M. in the Commissioners' office in Bozeman, Montana, at which time the Commissioners will make final determination of the merits of said matter, and at which time all persons interested may make objections or offer suggestions relative to the proposals in the Road Petition No. 616.
