PETITION FOR ROAD

NO. 619

To the Honorable Board of
County Commissioners of
Gallatin County, Montana

Gentlemen:

We, the undersigned freeholders of Gallatin County, taxable therein for road purposes, do hereby petition your Honorable Body to establish as a County Road the following described road:

Beginning at the west quarter corner of Section 5, T. 3S., R. 6E., M.P.M., thence running due east one-half ($\frac{1}{2}$) mile, more or less, to the center of said Section 5, Said road to be sixty (60) feet in width, being thirty (30) feet on either side of the above described line.

We further petition your Honorable Body to vacate as a public road the following County Road No. 60:

County Road No. 60, being 3,500 feet, more or less, in length and being more particularly described as follows:

Beginning at the corner common to Sections 31 and 32, T. 2S., R. 6E., and Sections 5 and 6, T. 3S., R. 6E.; thence east on the line between said sections 32 and 5, a distance of 3,500 feet, more or less, to the easterly end of said Road No. 60.

Said Road No. 60 to be abandoned after the new road, above described, is established and built. Also, when said Road No. 60 is abandoned, the land on either side of said line is to revert to the adjoining owners.

Also that when this new road is accepted as above described, that the old County Road No. 60, described in the petition be vacated and abandoned, and the land therein revert to the adjoining land owners. Said road No 60 is not practical to build or use. "

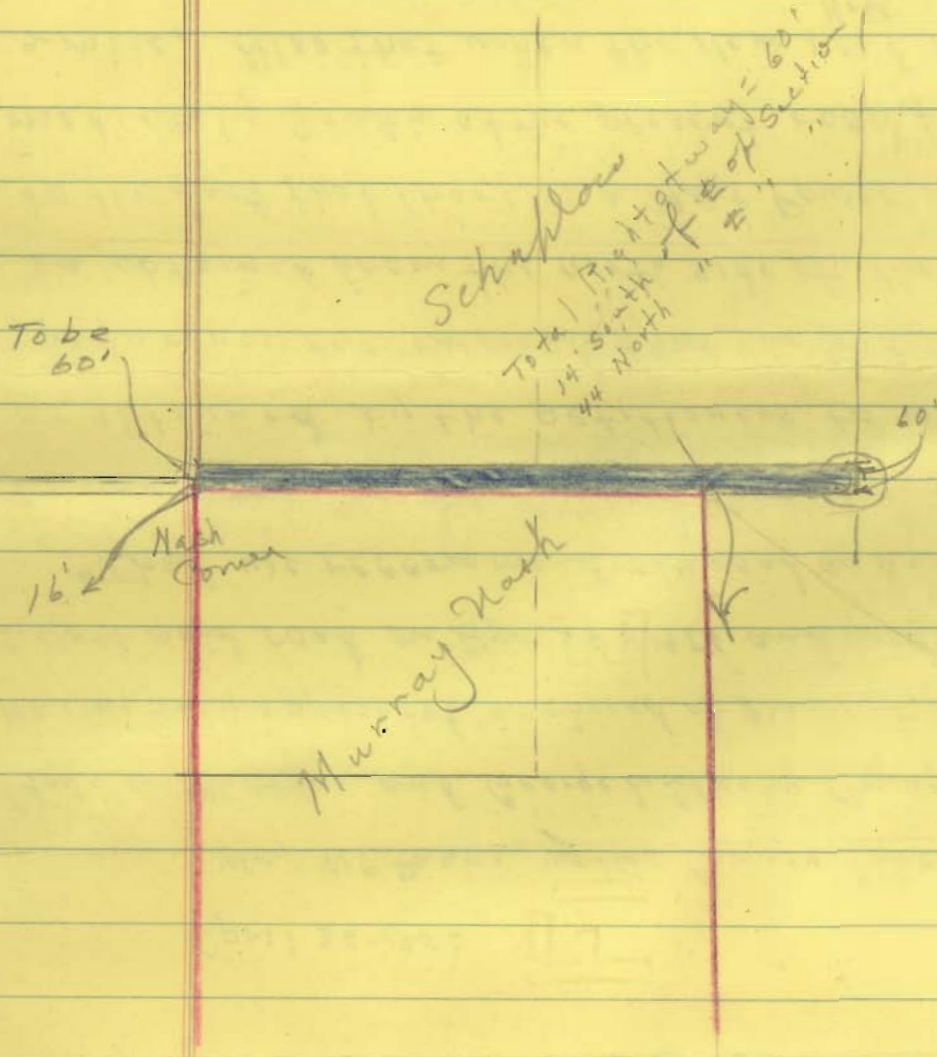

Also that when the New road is accepted as above described, that the old County road, ^{No 60} described in the above Petition be vacated and abandoned, and the land therein revert to the adjoining land owners."
