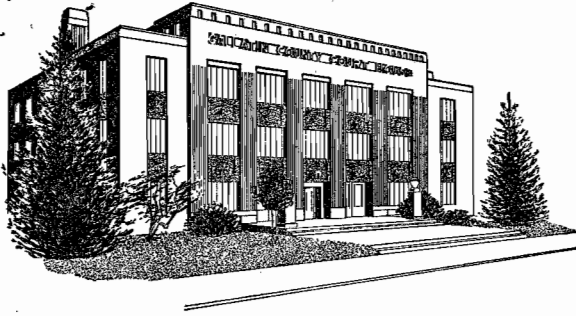
Gentlemen:

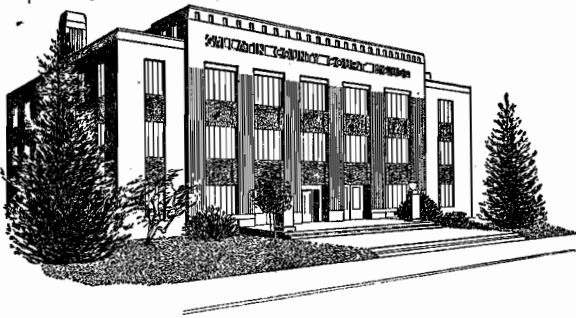

VIEWER'S REPORT

To The Honorable Board of County Commissioners.

I, W. C. Papke, a registered Land Surveyor in the State of Montana, being qualified to act as a member of a Board of Viewers, and George L. Stucky, County Commissioner of Gallatin County, State of Montana, having been appointed as a Board of Viewers for Road Petition No. 623, viewed said road on March 13, 1958, and wish to report:

" We recommend that the road described in said Petition be accepted, provided that the necessary right of way be obtained by the petitioners for a sixty foot right of way, and additional width where necessary; that this road is practicable and feasible to build, and will serve as a by pass south of the City of Bozeman for moving stock and farm equipment from east to west and visa versa; that a large percent of the property owners adjacent to this road are affiliated with Montana State College. The completion of this route would be of great value and importance to them."

(The actual centerline of this road will be surveyed and staked at a later date.)
