PETITION TO ABANDON ROAD

To the Honorable Board of
County Commissioners
Gallatin County, Montana

Gentlemen:

We, the undersigned freeholders of Gallatin County, Montana, taxable therein for road purposes, do hereby petition your honorable body to abandon as a public highway, the following described County road:

That portion of County road No. 351, known as the Haw Gulch road; and described as follows:

Beginning at the intersection with the Sixteen Mile road, in the southwest quarter (SW $\frac{1}{4}$) of Sec. 7, T.4N., R.5E., thence northerly and northwesterly through Sections 7 and 6, T.4N., R.5E. and Sec. 1, T.4N., R.4E., and Sections 36, 35, 26, 27, 22 and 15, T.5N., R.4E. ending at the County boundary line.

Total distance, Approximately 7 miles.

"We recommend that the road described in said Petition be closed for the following reasons:

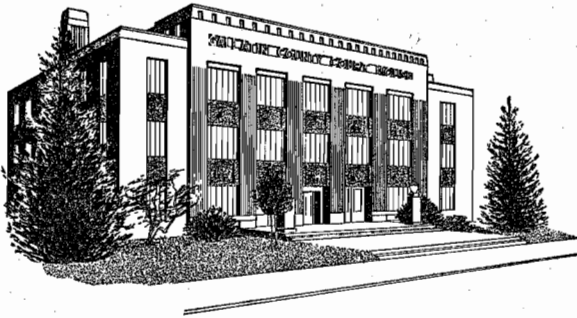
First: The land adjacent on both side to said road all belongs to one party, namely the Climbing Arrow Ranch.
