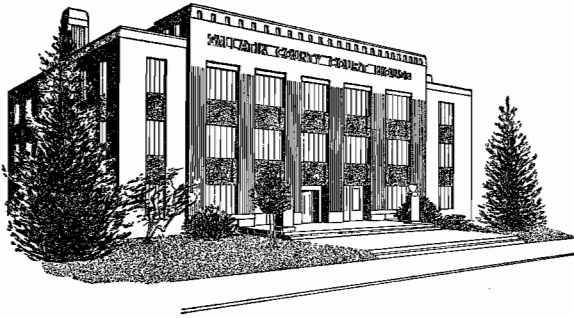
All of Cherry Street, which

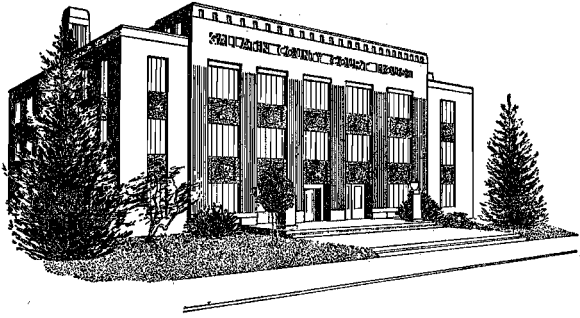

VIEWER'S REPORT

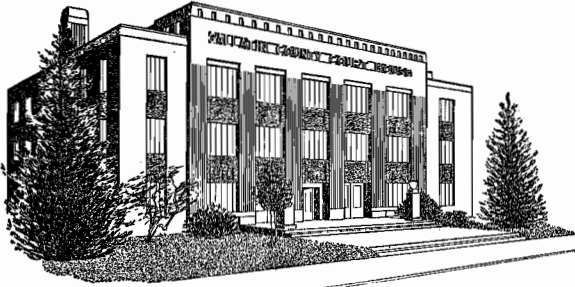
W. C. Papke, a registered Land Surveyor in the State of Montana, being qualified to act as a member of a Board of Viewers, and Ralph Aaker, County Commissioner of Gallatin County, State of Montana, having been appointed as a Board of Viewers for Road Petition No. 625, viewed said road on February 17, 1959 and wish to report:

"We have examined said Petition No. 625 and find it to have the necessary number of signatures. Upon examination of these signatures with adjacent land owners of property along Cherry Street, none of the signers are apparently listed. The property owners involved have the right of ingress and regression to their property along Cherry Street. It is our opinion that the street is doing no damage nor is it a nuisance to remain the way it is. It is our decision that Cherry Street should remain open."
