PETITION TO ABANDON ROAD

To the Honorable Board of
County Commissioners
Gallatin County, Montana

Gentlemen:

We, the undersigned freeholders of Gallatin County, Montana, taxable therein for road purposes, do hereby petition your honorable body to abandon as a public highway, the following portion of County Road No. 86:

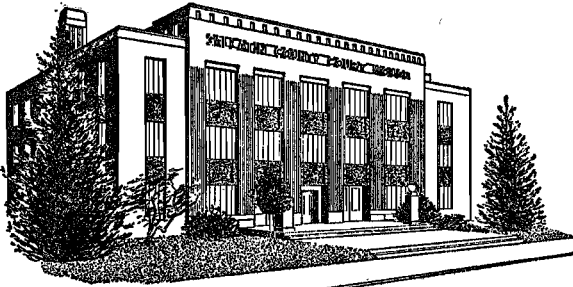
Beginning at a point on County Road No. 86, said point being 1966 feet south of the North Quarter corner of Section 15, T.2N., R.5E., said point also being 650 feet south of the east and west road and being just south of the Walter Storey driveway; thence from said point of beginning due south 3318 feet, to the South Quarter corner of said Section 15; thence east 1328 feet, thence south 9 degrees 31' E., 247.5 feet; thence south 14 degrees 11' E., 761.8 feet; thence south 31 degrees 27' E., 266.5 feet; thence south 15 degrees 41' E., 2712 feet, more or less, to a point on the east line of Sec.22, T.2N.R.5E.

VIEWERS REPORT

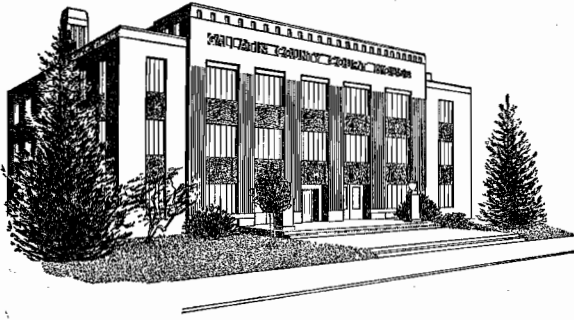

Papke, a registered land surveyor in the State of Montana, being qualified to act as a member of a Board of Viewers, and Paul Reese, County Commissioner of Gallatin, Commissioner of Gallatin County, State of Montana, having been appointed as a Board of Viewers, for Road Petition number 626, viewed said road on April 23rd, 1959 and wish to report:

" We have examined said petition No. 626 and find it to have sufficient signatures. Upon examination of these signatures with adjacent land owners of the property along County Road No. 626 as described in said petition, we found that there is no necessity for such road since a new road, with gravelled surface has been built in its stead. Upon further examination, we found that the portion of this road in section 15, described in the petition, has been under cultivation for several years. Also that there are no families or persons living along the road proposed to be closed"

In view of the foregoing facts we reccomend that this road be vacated and Closed.
