PETITION TO ABANDON ROAD

To The Honorable Board of
County Commissioners
Gallatin County, Montana

Gentlemen:

We, the undersigned freeholders of Gallatin County, Montana, taxable therein for road purposes, do hereby petition your honorable body to abandon as a public highway, the following portion of the Springhill road:

Beginning at a point on said road, said point being 2,000 feet, more or less, north of the south line of Section 23, T.1S., R. 5E.; Thence N. 14° 19' E. 471.5 feet; thence N. 11° 12' W. 535.8 feet; to a point in the present Springhill road.

The object of this petition is to officially abandon an old section of Springhill road, which was replaced in 1939 when road was straightened thru the N ½ of SE ¼ and the S ½ of the N.E. ¼ of Sec. 23.

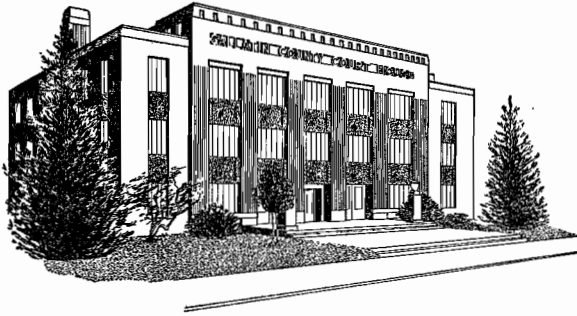

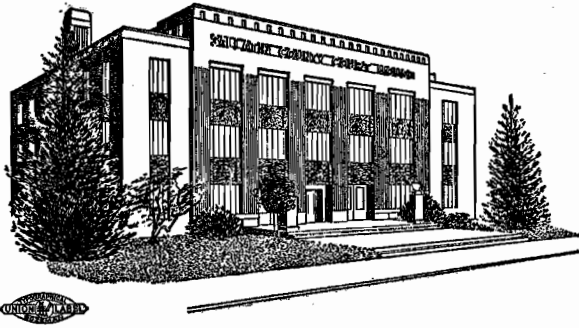

" We examined said Petition No. 627 and find it to have sufficient signatures. We found that a new oiled road has been built in its stead, and th at there is absolutely no need or use for the road to be abandoned. We also found that most of the right of way in question is and has been under cultivation for several years. However there is the old bridge on the road to be abandoned. We wish to suggest that Gallatin County relinquish all rights and responsibilities to the bridge."

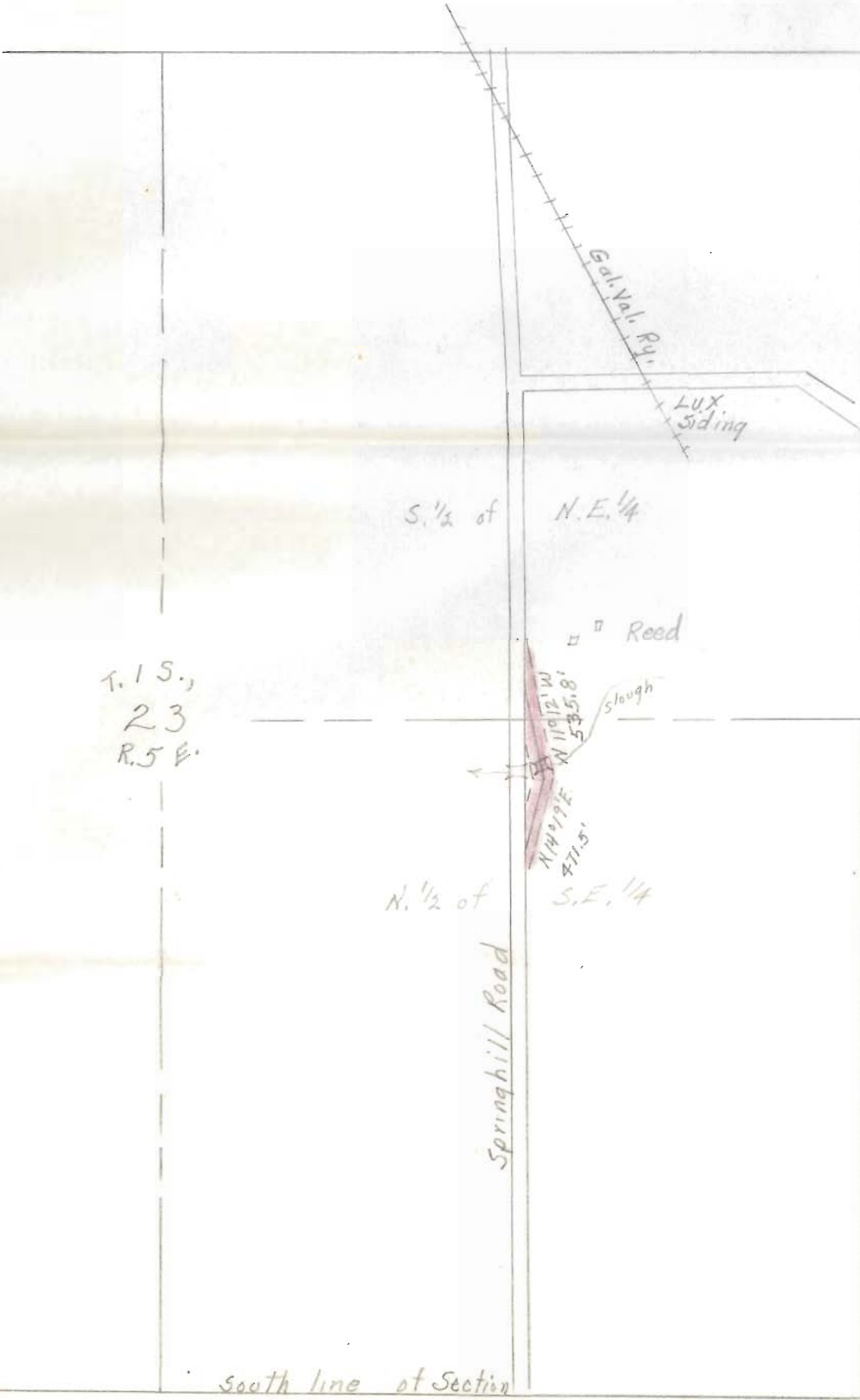
In view of the foregoing facts we reccomend that this road, as described in said petition be vacated and closed.
