PETITION TO ABANDON ROAD

To The Honorable Board of  
County Commissioners  
Gallatin County, Montana

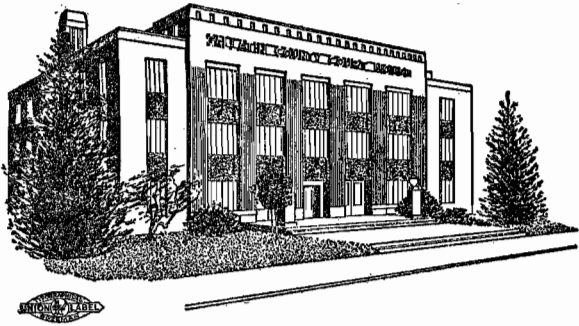
Gentlemen:

We, the undersigned Freeholders of Gallatin County, Montana, taxable therein for road purposes, do hereby petition your honorable body to abandon as a public highway, That portion of the old Bridger Road No. 64, in Section 30, Township One South, Range Seven East, and being more particularly described as follows, and shown in red on the attached plat:

Beginning at a point on the westerly right-of-way of Bridger Road Project No. FAS 370-D (1) at Station 371 + 80, said point being 570 feet north of the Section line between Sec. 30 and Sec. 31; thence N. 23° 15' W., 400 feet; thence N. 16° E. 329.5 feet; thence N. 33° E. 400 feet, more or less to the westerly right-of-way of Project FAS 370-D (1).

Total distance; 0.24 mile.

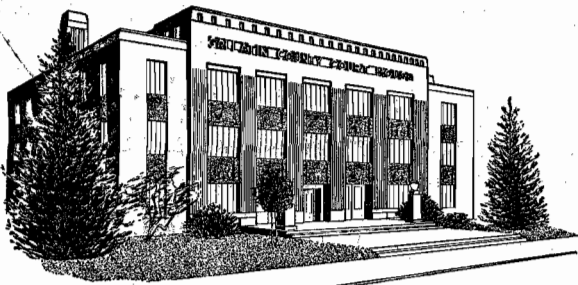

This is to notify you that the Board of County Commissioners has accepted the report of the Board of Viewers, Mr. W. C. Fapkef, Private Surveyor, and Commissioners Ralph K. Asker, on Road Petition No. 629. This petition is for the abandonment of the following described County Road:

A portion of the Bridger road near Bob Arnold and Floyd David where the new Bridger oil was straightened, a distance of 0.24 miles, in Sec. 30, T.1S., R.7E.

A hearing on the above matter has been set by the Board of County Commissioners for Monday, July 30, 1962, at 10 o'clock A. 

VIEWERS REPORT

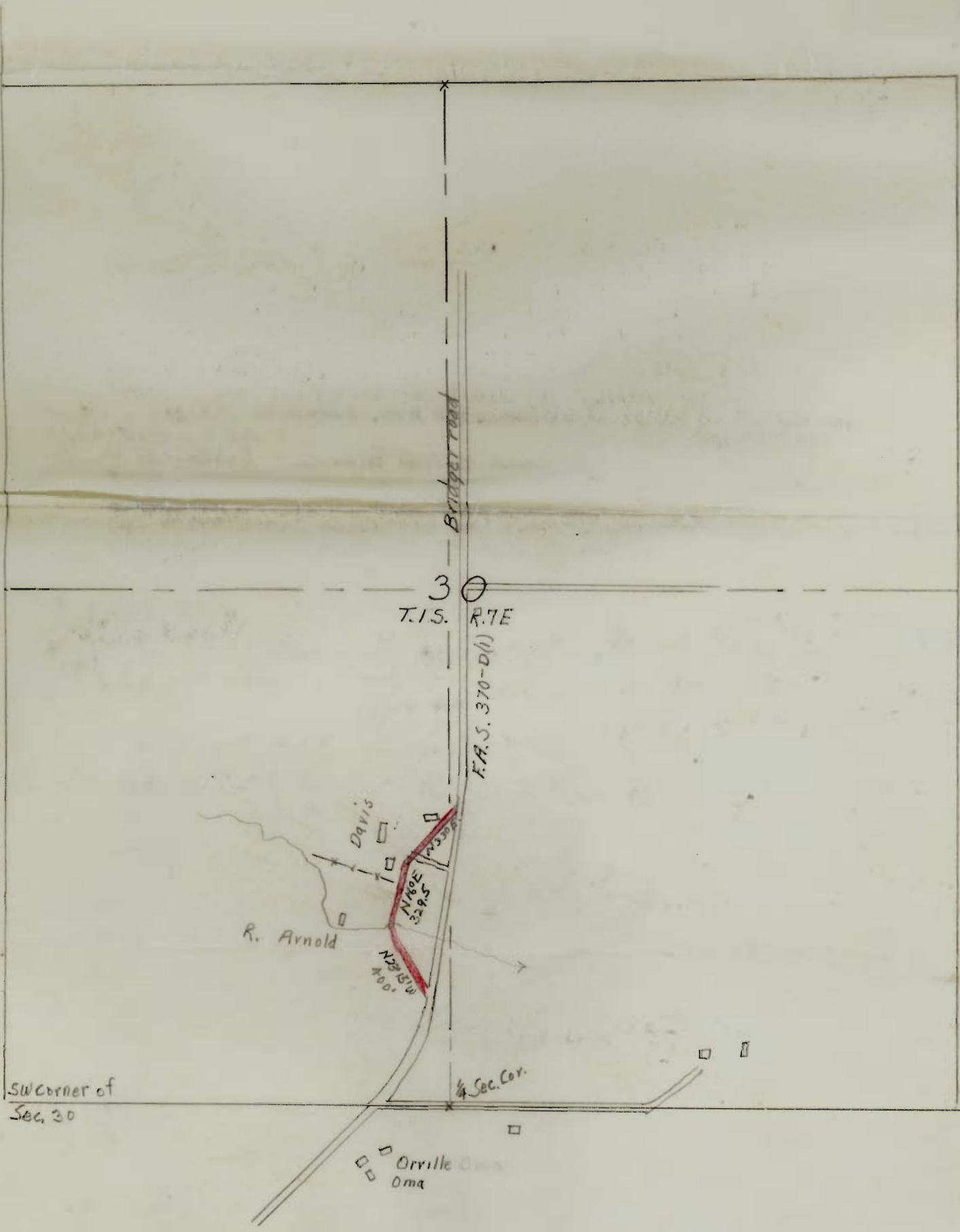
W. C. Papke, a registered land surveyor in the State of Montana being qualified to act as a member of a Board of Viewers, and Ralph K. Aaker, County Commissioner of Gallatin Commissioner of Gallatin County, State of Montana, having been appointed as a Board of Viewers, for Road Petition number 629, viewed said road on July 16th, 1962, and wish to report:

"We examined said Petition No. 629 and find it to have sufficient signatures. Upon examination of the signatures with adjacent land owners of the property along County road No. 629, as described in said petition, we found that there is no necessity for such Road since a new oiled road has been built in its stead. Upon further examination, we found that a portion of the road in question is under cultivation, and that there are several fences and gates across this road."

In view of the foregoing facts we recommend that this road be vacated and closed.
