PETITION TO ABANDON ROAD.

TO THE HONORABLE BOARD OF
 COUNTY COMMISSIONERS,
 GALLATIN COUNTY, MONTANA.

Gentlemen:

We, the undersigned Freeholders of Gallatin County, Montana, taxable therein for road purposes, do hereby petition your honorable body to abandon as a public highway, a portion of the old road on Griffin Drive, known also as the Livestock Road West, and being more particularly described as follows:

Beginning at a point on said road which is 120 feet, more or less, west of the westerly edge of the East Gallatin bridge, and being on the northerly side of the right of way of the present road: thence N. 79° 47' W. 353 feet; thence S. 79° 31' W. 230 feet, more or less, to a point on the northerly right of way of the said present County road as built about 1953.

All of the above portion of road was replaced by a new section of road and lies in the NE $\frac{1}{4}$ of Sec. 6, T. 2 S., R. 6 E.

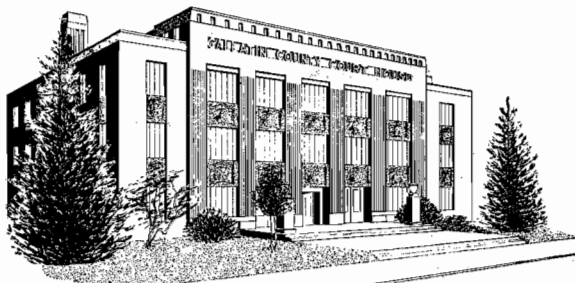

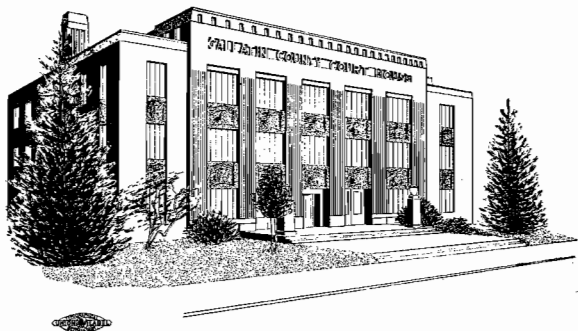



VIEWERS REPORT

W. C. Papke, a registered land surveyor in the State of Montana, being qualified to act as a member of a Board of Viewers and Ralph Armstrong, County Commissioner of Gallatin County, State of Montana, having been appointed as a Board of Viewers for Road Petition No. 633, viewed said road on the 25th day of September, 1963 and wish to report:

"We examined said petition No. 633 and find it to have sufficient signatures. We found that there are no people living along said road described in the petition; that there is a new oiled road built in its stead, that the new road eliminated a couple of curves in the old road. There is absolutely no need or further use, for the road described in said petition No. 633. Also, there is a new fence, (steel posts and four wires) built along the new oiled Road. We suggest that this old road described in Petition No. 633 be vacated and closed."
