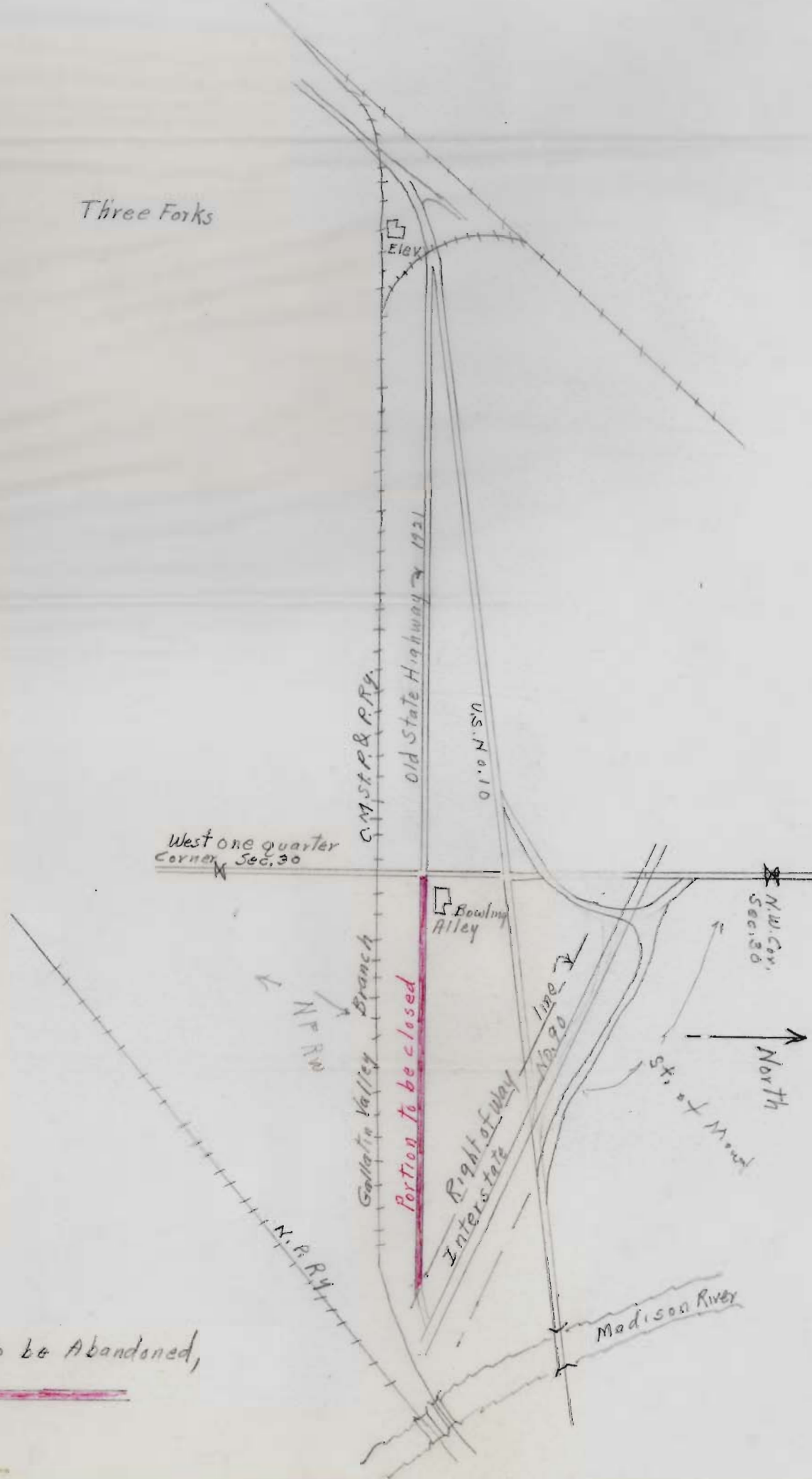

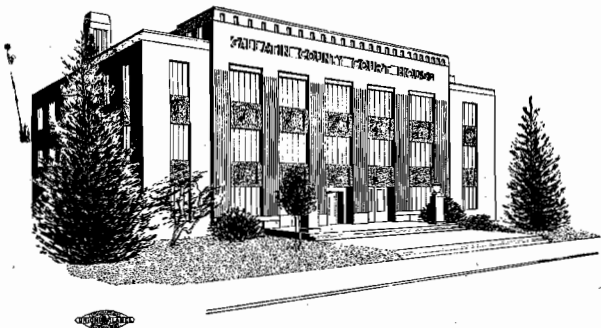

VIEWERS' REPORT

W. C. Papke, a registered Land Surveyor in the State of Montana, being qualified to act as a member of a Board of Viewers and Leslie O. Anderson, Gallatin County Commissioner, having been appointed as a Board of Viewers for Road Petition Number 635, viewed said road on April 1, 1965, and wish to report"

"We examined said road and find it to have sufficient signatures. We found that there are no people living along or adjacent to said road as described in said Petition, that it is a dead end road, that there is no absolute use for said road; that there is a new Interstate Highway, which takes care of all traffic, the property on the northerly side of the road belongs to the State of Montana, and the property on the south belongs to the Gallatatin Valley Branch of the Chicago, Milwaukee, St. Paul and Pacific Railway; the road in question is part of the old Yellowstone Trail. The new Insterstate Highway takes care of the Old Yellowstone Trail as mentioned above and described in petition. In view of the foregoing facts, we recommend that the road in question be vacated and closed."


