PETITION TO ABANDON ROAD

TO THE HONORABLE BOARD OF
COUNTY COMMISSIONERS,
GALLATIN COUNTY, MONTANA.

GENTLEMEN:

We the undersigned Freeholders of Gallatin County, Montana, taxable therein for road purposes, do hereby petition your honorable body to abandon as a public highway, a portion of the streets and alleys in the Townsite of Central Park, Gallatin County, Montana, being in Section 19, T.1 N., R.4 E., M.P.M., and being more particularly described as follows:

The East-West Alley in Blocks No. 1, 3, 4, 5, 6 and 7; that part of Penwell Street lying between Block 4 and Block 5 and that part lying between Block 2 and Block 3-North of the Alley; all of Riverside Street, lying North of the Highway No. 10; that part of Park Avenue lying between Block 1 and Block 7 and the South 30 feet of Park Avenue lying North of Block 6.

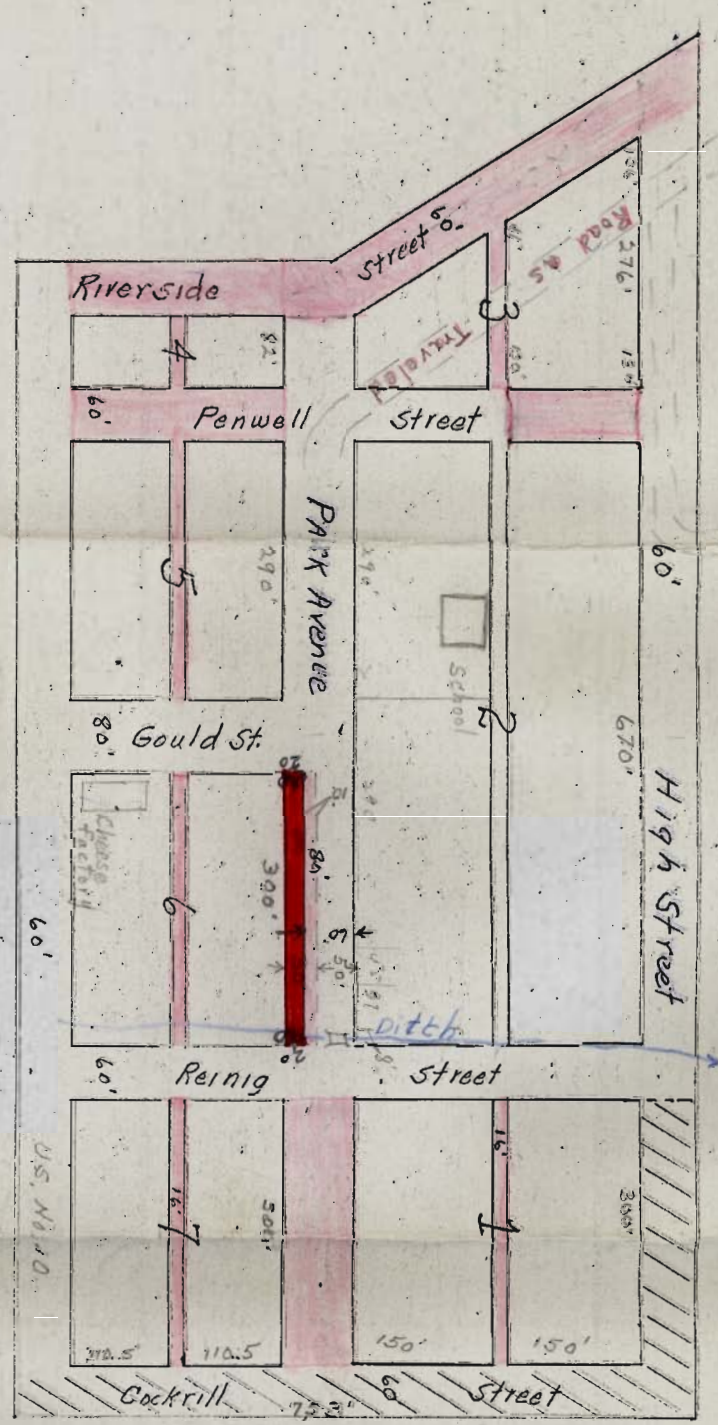

R E S O L U T I O N

WHEREAS, petition to abandon a road was filed with the Gallatin County Commissioners requesting the board to abandon that portion of the alley and streets in the townsite of Central Park, Gallatin County, Montana, being in Section 19, Township 1 North, Range 4 East, M.P.M., and being more particularly described as follows:

The East-West alley in Blocks No. 1, 3, 4, 5, 6 and 7; that part of Penwell Street lying between Block 4 and Block 5 and that part lying between Block 2 and Block 3 - North of the alley; all of the Riverside Street, lying North of the Highway No. 10; that part of Park Avenue lying between Block 1 and Block 7 and the South thirty feet of Park Avenue lying North of Block 6.

and,

WHEREAS, the street and alley was inspected by Earl R. Best and Ralph Armstrong and they recommended that the street and alley be abandoned and closed to public use,

and,

WHEREAS, the petitioners and the adjacent land owners were notified that the board of county commissioners had accepted the report of the viewers, and that a public hearing would be held on the 29th day of September, 1966 at 10:00 o'clock A.M. The hearing was held as scheduled, no protests were heard, and the road was therefore declared abandoned.

NOW, THEREFORE, BE IT RESOLVED that that portion of the alley and street in the townsite of Central Park in Section 19, Township 1 North, Range 4 East, M.P.M. and more particularly described as follows:

The East-West alley in Blocks No. 1, 3, 4, 5, 6 and 7; that part of Penwell Street lying between Block 4 and Block 5 and that part lying between Block 2 and Block 3 - North of the alley; all of the Riverside Street, lying North of the Highway No. 10; that part of Park Avenue lying between Block 1 and Block 7 and the South thirty feet of Park Avenue lying North of Block 6.
