GENTLEMEN:

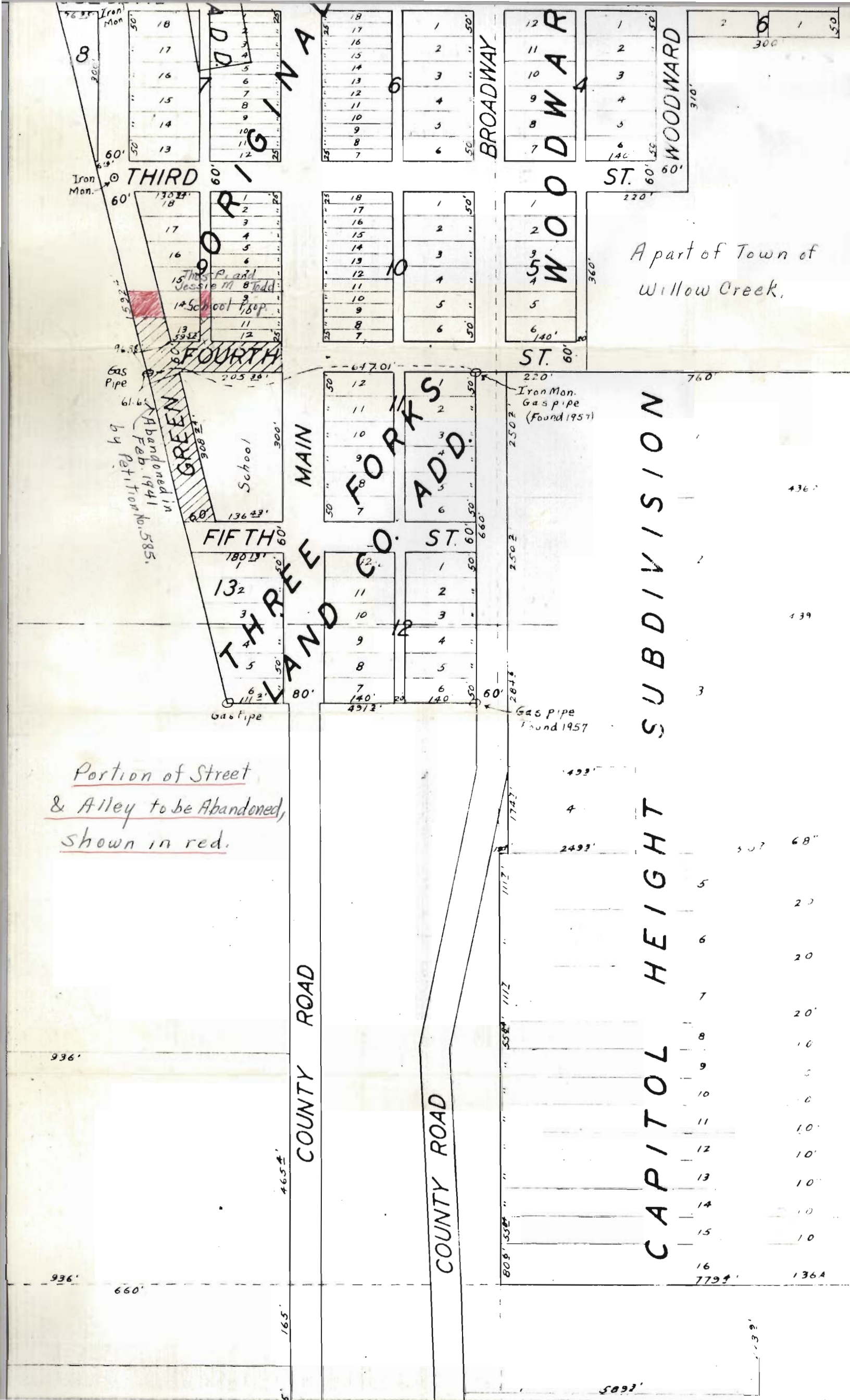
All that portion of Green Street lying west of Lot 14 in Block 9 and that portion of the Alley in Block 9, lying between Lots 9, 10 and 14.






