Beginning at North Line of Section 30 where Road Number 39
 intersects with Road Number 3; thence straight South for a
 distance of 4,210 feet to the intersection of Road No. 1
 and Road No. 39, in Section 30, Township 1 North, Range
 5 East.

Re: Road Number 39 (Grogan Lane)

Attached herewith is a petition to abandon the road referred to above, signed by those parties immediately concerned. Said road is in Section 30, Township 1 North, Range 5 East, more particularly as follows:

Beginning at North line of Section 30 where
Road Number 39 intersects with Road Number 3;
thence straight South for a distance of 4,210 ft
to the intersection of Road No. 1 and Road No. 39,
in Section 30, Township 1 North, Range 5 East.

Approximate total distance is 4,210 feet.

New fencing is required as well as general cleanup of the area in keeping with today's ecology and anti-pollution movements and little, if anything, can be done until said Grogan Lane is abandoned and closed to public trespass. Rights-of-way to The Mountain States Telephone & Telegraph Company (now known as Mountain Bell) and The Montana Power Company for their services, furnished through joint use of poles, are not affected through this request.

We respectfully request your attention to this petition, and thank you.

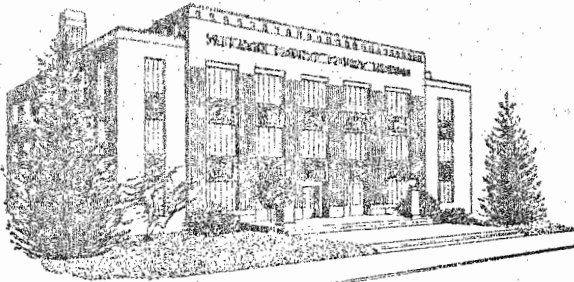
