GENTLEMEN:

We the undersigned Freeholders of Gallatin County, Montana, taxable for road purposes, do hereby petition your honorable body to abandon as a public road, a portion of an alley and street in the townsite of Central Park, in Section 19, Township 1 North, Range 4 East, M.P.M., and being more particularly described as follows:

The North-South alley in Block Number 3 lying between Lots Number 1, 2, 3, 7 and 8, less the portion of county road that crosses this alley, and the portion of Park Avenue lying between blocks 3 & 4.

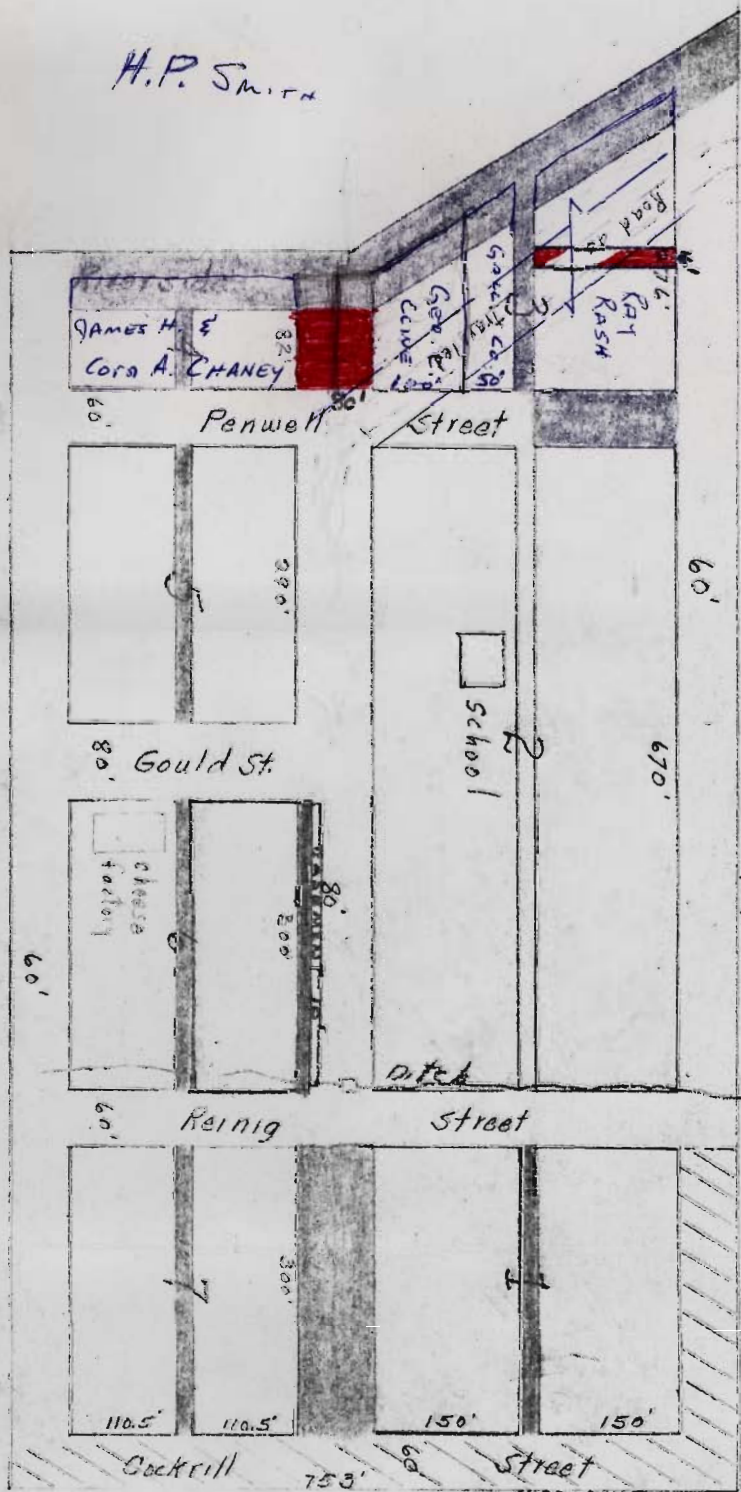
Plat attached showing portion to be abandon in red.

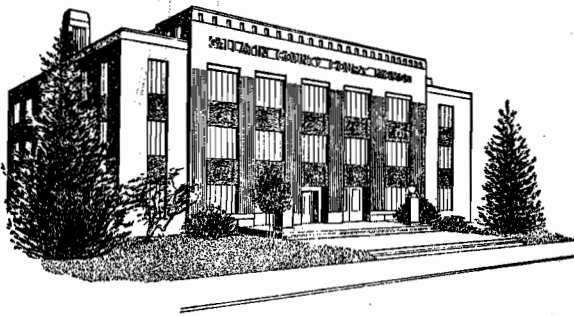

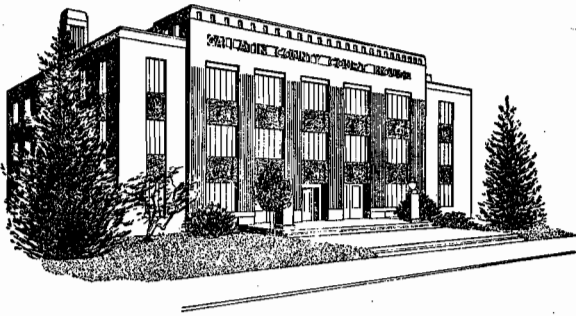

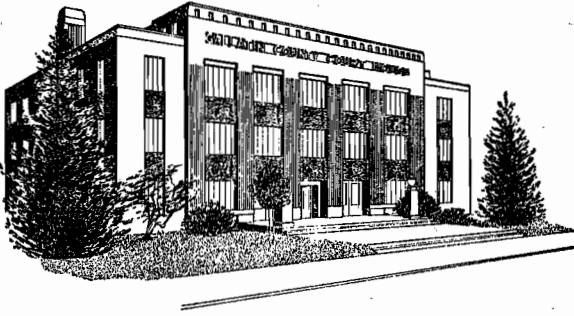
