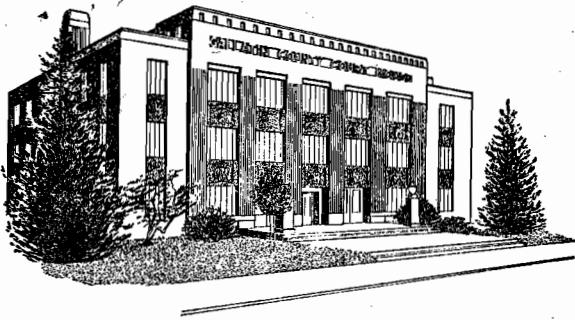
2 miles of county road, running east and west, situated on section lines between section 9 and 16, also between section 10 and 15, all in Township 1 North, Range 5 East.



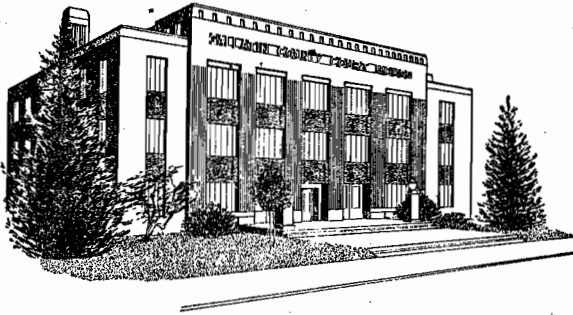

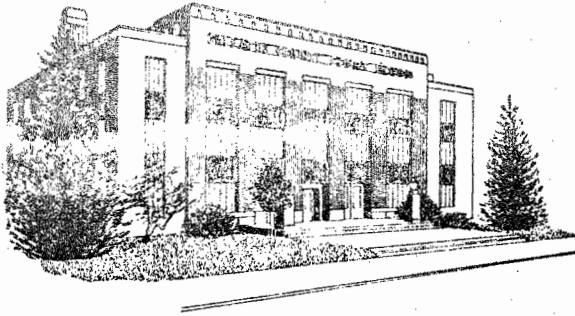
Unless a landowner or taxpayer wants to protest this petition you are not required to attend.
