(3) South, Range Six (6) East, described as follows:

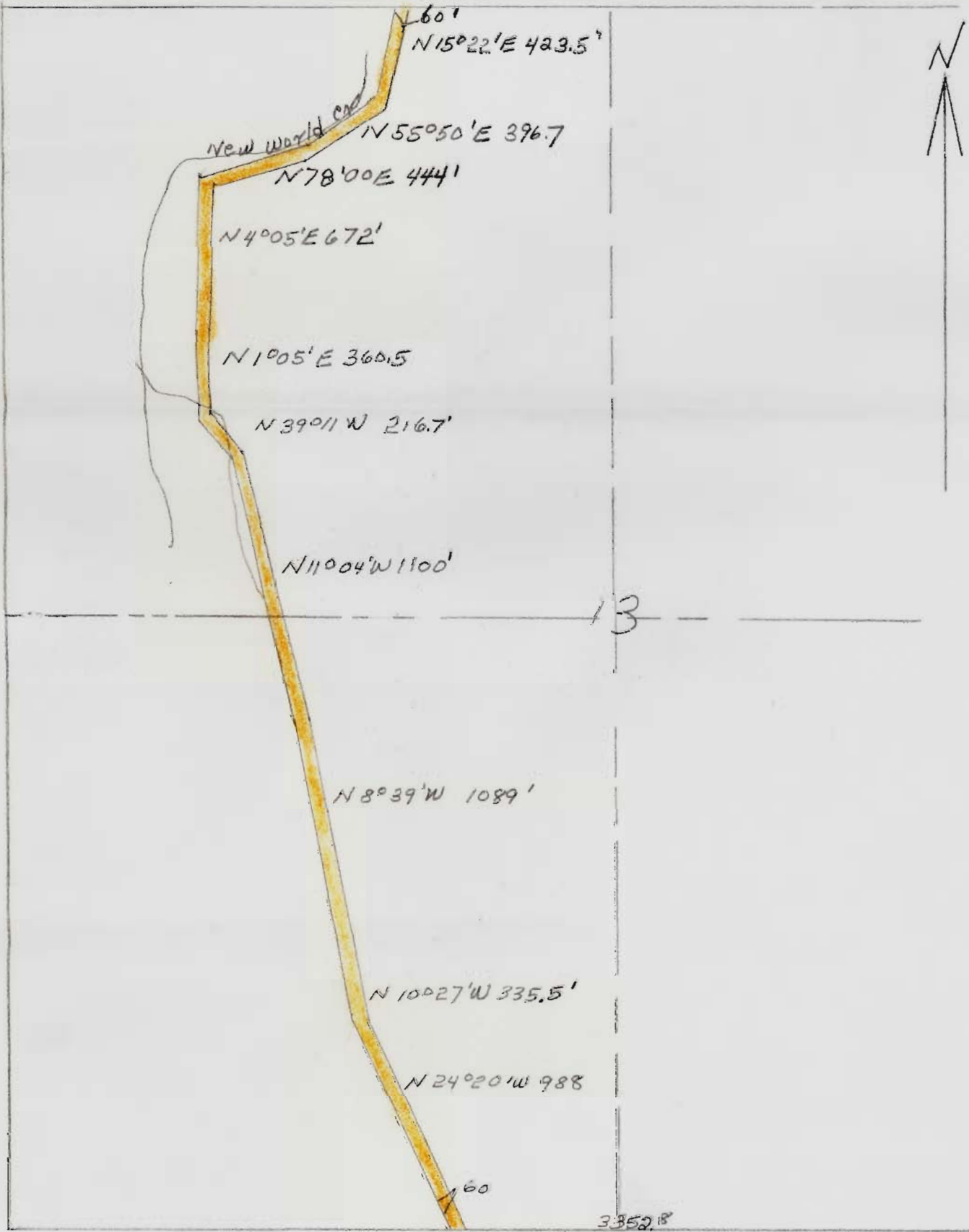
A strip of land sixty (60) feet in width being thirty (30)

thence North 8 degrees 39 minutes West 1089.0 feet; thence
North 11 degrees 4 minutes West 1100.00 feet; thence North
39 degrees 11 minutes West 216.7 feet; thence North 1 degree
5 minutes East, 360.5 feet; thence North 4 degrees 5 Minutes
East, 672.0 feet; thence North 78 degrees East, 444.0 feet;
thence North 55 degrees 50 minutes East, 396.7 feet; thence
North 15 Degrees 22 Minutes East, 423.5 feet, more or less
to the North line of said Section 13, containing 8.3 acres

Total distance approximately 6,025.9 feet.

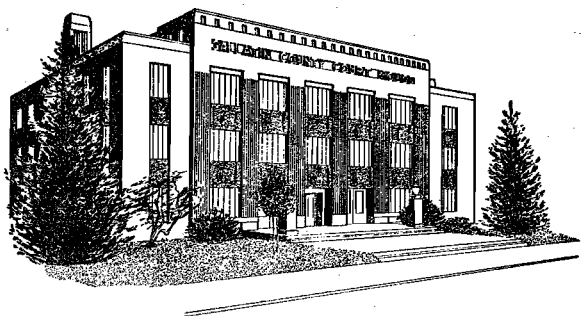

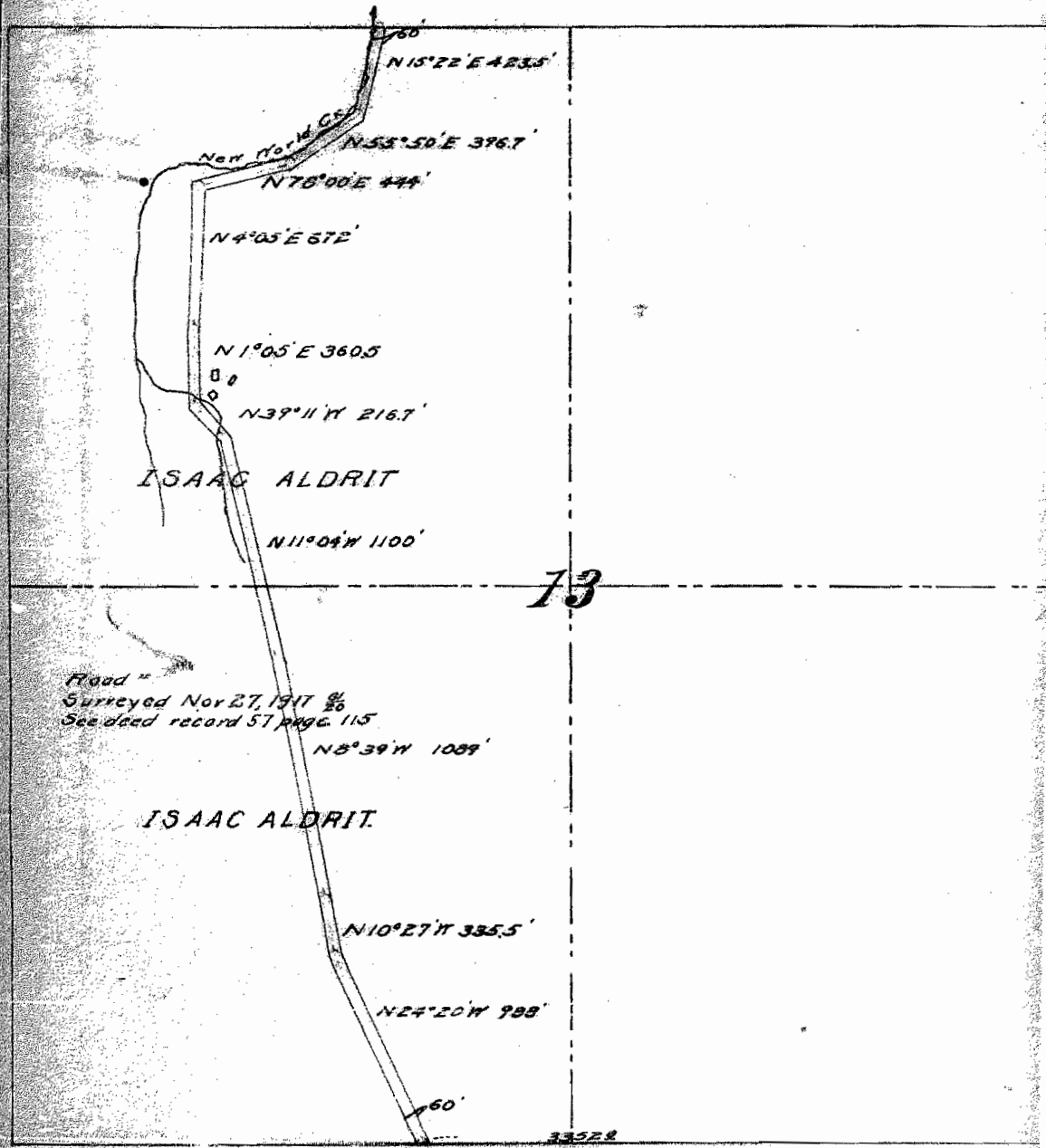
