ROAD PETITION FOR OPENING NEW PORTION OF KELLY CANYON ROAD AND CLOSING A PORTION OF THE OLD SECTION

To the Honorable Board of
County Commissioners
Gallatin County, Montana

Gentlemen:

We, the undersigned taxpayers of Gallatin County, taxable therein for road purposes, do hereby petition your Honorable Body to establish as a county road a strip of land 60.0 feet wide being 30.0 feet each side of the following described center line.

Beginning at a point 50' South of the Township Corner common to Section one (1), Township 2 South, Range 6 East and Section six (6) in Township 2 South, Range 7 East Montana Principal Meridian; thence South $68^{\circ}40'52''$ East a distance of 303.6 feet to the P.C. of a 10° curve right; thence along the curve having a radius of 573.0 feet and through a central angle of $9^{\circ}29'30''$, a distance of 94.9 feet, to station 3 \angle 98.5; thence South $59^{\circ}11'21''$ East a distance of 92.0 feet to P.C. Station 4 \angle 90.5, thence along a $15^{\circ}00'$ curve to the right, having a radius of 382.0 feet, and through a central angle of $30^{\circ}33'$, a distance of 203.7 feet to Station 6 \angle 94.2; thence South $28^{\circ}38'21''$ East a distance of 460.9 feet to P.C. Station 11 \angle 55.1, thence along a $15^{\circ}00'$ curve to the left, having a radius of 382.0 feet and through a central angle of $36^{\circ}44'$, a distance of 244.9 feet to station 14 \angle 00 back equals 13 \angle 92.0 ahead; thence South $65^{\circ}22'$ East, a distance of 67.7 feet to P.C. Station 14 \angle 59.7; thence along a $30^{\circ}00'$ curve to the right having a radius of 191.0 feet, and through a central angle of $42^{\circ}05'$, a distance of 140.3 feet to P.T. station 16 \angle 00; thence South $23^{\circ}17'$ East a distance of 410.3 feet to P.C. Station 20 \angle 10.3; thence along a $5^{\circ}00'$ curve to the right, having a radius of 1146.0 feet, and through a central angle of $8^{\circ}23'$, a distance of 167.7 feet, to station 21 \angle 78.0; thence South $14^{\circ}54'$ East, a distance of 68.3 feet to P.C. Station 22 \angle 46.3; thence along a $5^{\circ}00'$ curve to the left having a radius of 1146.0 feet, through a central angle of $14^{\circ}55'$, a distance of 298.3 feet to Station 25 \angle 44.6; thence South $29^{\circ}49'$ East, a distance of 91.6 feet to P.C. Station 26 \angle 36.2; thence along a $5^{\circ}00'$ curve to the right, having a radius of 1146.0 feet, and through a central angle of $16^{\circ}11'$ right, a distance of 323.7 feet to station 29 \angle 59.9; thence South $13^{\circ}38'$ East, a distance of 40.1 feet to Station 30 \angle 00; thence a strip of land 80.0 feet in width being 50.0 feet on the right and 30.0 feet left of the following described center line; thence continuing South $13^{\circ}38'$ West, a distance of 191.9 feet to the P.C. at Station 31 \angle 91.9; thence along a $15^{\circ}00'$ curve to the right, having a radius of 382.0 feet, and through a central angle of $49^{\circ}12'$, a distance of 328.0 feet at station 35 \angle 19.9; thence South $35^{\circ}34'$ West, a distance of 322.4 feet to P.C. Station 38 \angle 42.3; thence a strip of land 60.0 feet in width being 30.0 feet on each side of the following described centerline; thence along a $7^{\circ}30'$ curve to the left, having a radius of 764.0 feet and through a central angle of $19^{\circ}28'$, a distance of 259.6 feet to Station 41 \angle 01.9; thence South $16^{\circ}06'$ West, a distance of 1398.1 feet to where the road intersects with the county road.

Beginning at the Northwest Quarter of Section 6, Township 2 South, Range 7 East, Montana Principal Meridian; thence South $67^{\circ}45'$ East, a distance of 600 feet; thence South $24^{\circ}13'$ East, a distance of 686 feet; thence South $64^{\circ}15'$ East a distance of 300 feet; thence South $36^{\circ}51'$ East, a distance of 540 feet; thence South $10^{\circ}23'$ East, a distance of 282 feet; thence South $36^{\circ}23'$ East, a distance of 288 feet; thence South $15^{\circ}25'$ East, a distance of 287 feet; thence South $34^{\circ}40'$ East, a distance of 181 feet; thence South $47^{\circ}46'$ East, a distance of 170 feet;

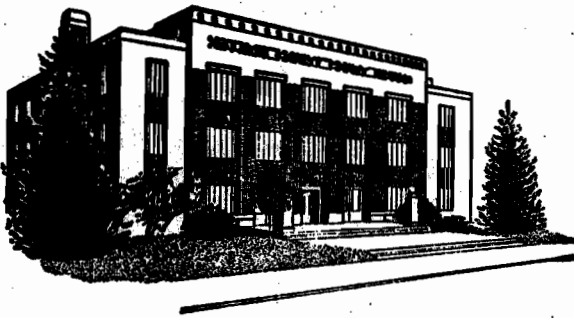

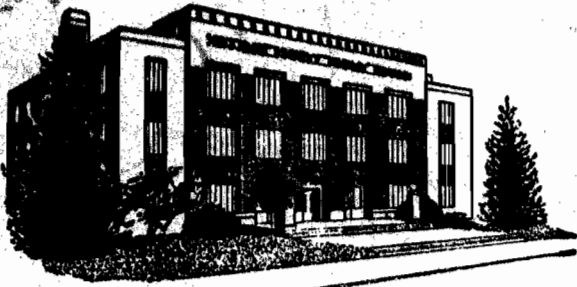

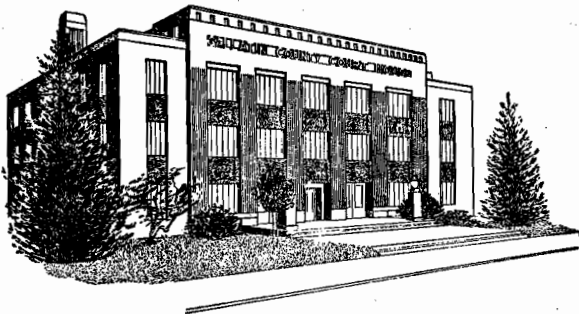
