PETITION TO ABANDON ROAD

To the Honorable Board of County Commissioners
Gallatin County, Montana

Gentlemen:

We, the undersigned Freeholders of Gallatin County, Montana taxable therein for road purposes, do hereby petition your honorable body to abandon as a public highway, that portion of the old Bridger Road No. 64, in Section 30, Township One South, Range Seven East, and being more particularly described as follows, and shown in red on the attached plat:

Beginning at a point on the westerly right-of-way of Bridger Road Project No FAS 370-D (1) at Station 371 + 80, said point being 570 feet north of the Section line between Sec. 30 and Sec. 31; thence N. 23° 15' W., 400 feet; thence N. 16° E. 329.5 feet; thence N. 33° E. 400 feet, more or less to the westerly right-of-way of Project FAS 370-D (1).

Total distance: 0.24 mile

Pursuant to Section 32-4003, Revised Codes of Montana, 1947, as amended, the general route of the road to be abandoned is as stated above. The lands and owners affected thereby are set forth below and said owners consent to the proposed abandonment. There is no cost to the county for this action and the action of abandonment is necessary to remove this public road from the records of the county and to permit the creation of a new and safer access to the lands of the petitioners.



That the action taken by the Board of County Commissioners of Gallatin County, Montana, in 1962 to vacate Gallatin County

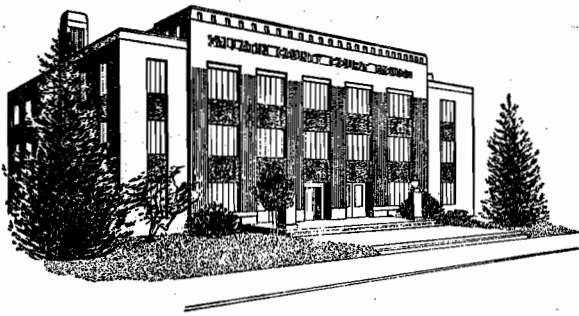
Road Number 64 is hereby set aside and it is declared a public road;





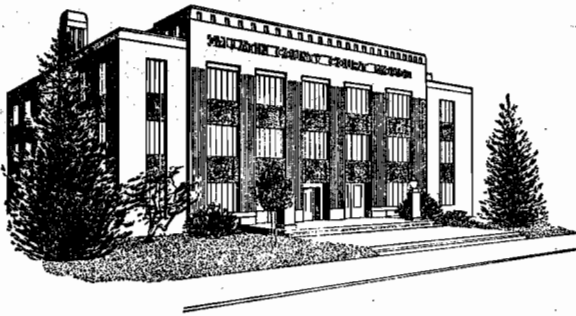
