PETITION TO ABANDON PORTION OF COUNTY ROAD

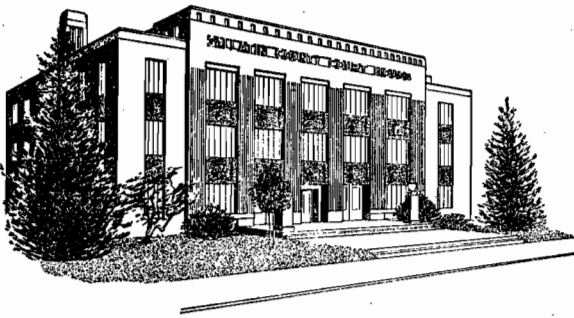
To the Honorable Board of

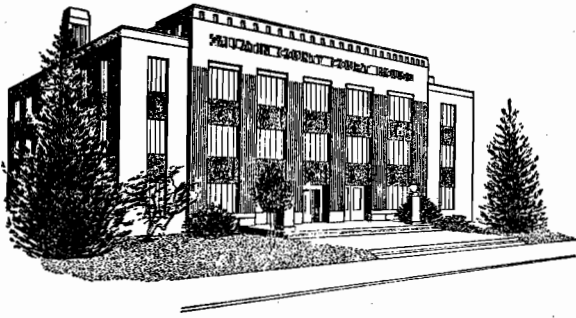
