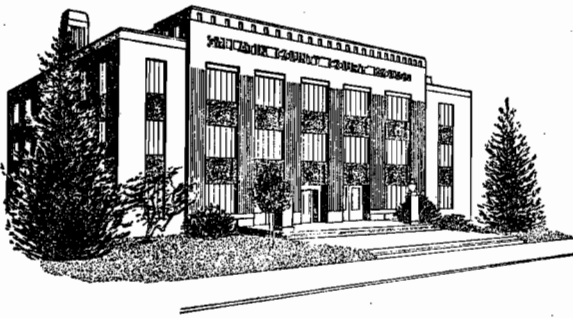

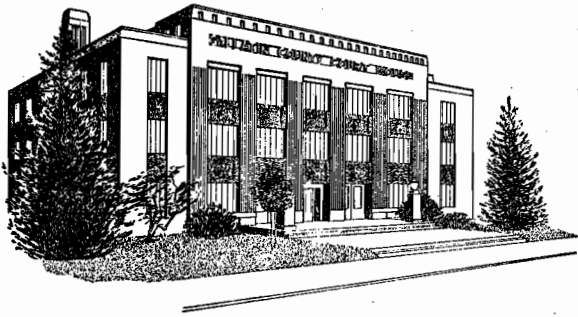
Unless a landowner wants to protest this petition you are not required to attend.
