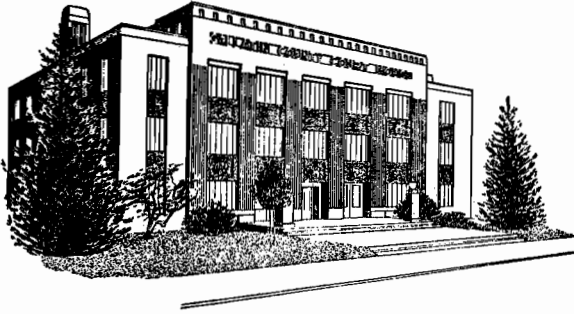

Unless a landowner or taxpayer wants to protest this petition you are not required to attend.

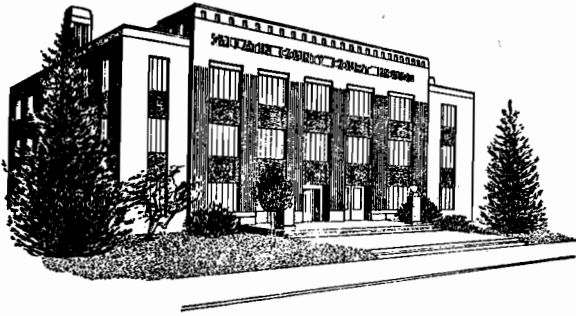
