
BOARD OF VIEWERS REPORT

We, the undersigned, acting as the Board of Viewers for Gallatin County., made inspection of the alley as described in Petition No. 670.

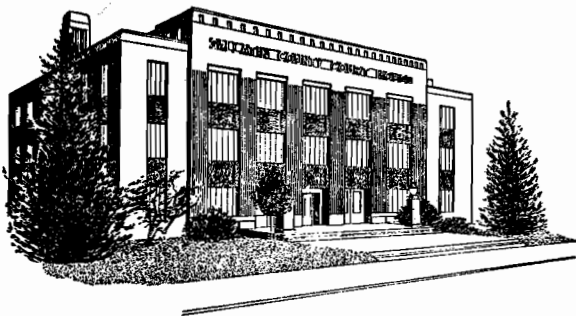
It was found that the alley no longer served a useful benefit to the Petitioners and therefore have recommended the alley to closed to public use..

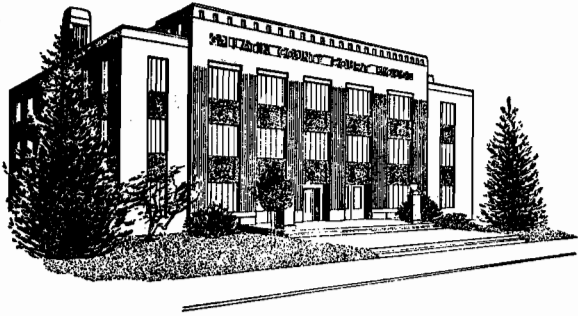
Unless a landowner or taxpayer wants to protest this petition you are not required to attend.
