PETITION TO ESTABLISH COUNTY ROAD

To the Honorable Board of
 County Commissioners
 Gallatin County, Montana

Gentlemen:

We, the undersigned Freeholders of Gallatin County, Montana, taxable therein for road purposes, do hereby petition your Honorable Body to establish as a county road a strip of land 60.0 feet in width with such additional width as is necessary to accommodate and protect cuts and fills, over and across the following described lands in the County of Gallatin, State of Montana.

Beginning at a point in the centerline of Road No. 167.2 which bears South 89° 3' 4" West, a distance of 93.37 feet from the S 1/16 corner between Sections 9 & 10, T13S, R4 E, PMM, thence in a Northeasterly direction along the Centerline of Road No. 167.2 and known as the Denny Road to the intersection of the section line common to sections 9 & 10, T13S, R4E, PMM, thence along the section line common to sections 9 & 10 and sections 3 & 4, T13S, R4E, PMM, to the S 11/16 corner common to sections 3 & 4, T13S, R4E, PMM, thence following the centerline of the existing road no. 167.2 lying West of the section line common to sections 3 & 4, T13S, R4E, PMM to the point of intersection with said section line which point bears North 419.58 feet from the S 1/16 corner between section 3 & 4 T13S, R4E, PMM


