To the Honorable Board of

We, the undersigned Freeholders of Gallatin County, Montana taxable herein for road purposes, do hereby petition your honorable body to abandon as a sub-division road a strip of land 20.0 feet in width in the Rainbow sub-division, and being more particularly described as follows, and shown in red on the attached plat.

Starting point at the Southwest corner of lot 283 in the Rainbow Subdivision in Section 23, Township 2 South, Range 4 East, thence North 89° 57' East, a distance of 498 feet to the Southeast corner of lot number 286 in the Rainbow Subdivision.

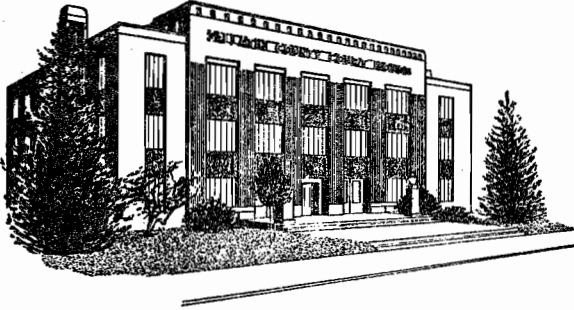



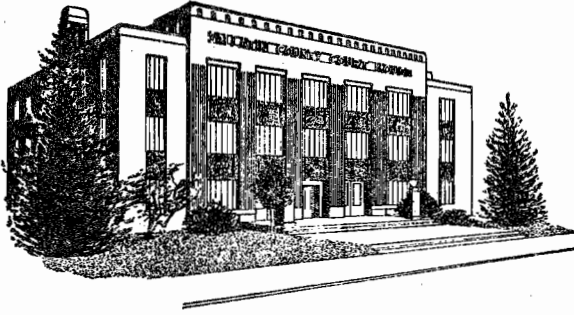
PETITION NO. 673



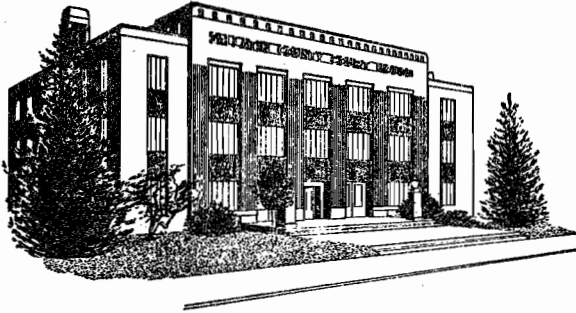

There being no objections it was unanimously carried by the Board of County Commissioners that the road be closed.






