To the Honorable Board of

Gentlemen:

We, the undersigned freeholders of Gallatin County, taxable for road purposes, do hereby petition your Honorable Body to abandon the following portion of County road, in Township 3 South, Range 3 East, and being more particularly described as follows;

Beginning at a point 30 feet West of the Northeast corner of Section 13, Township 3 South, Range 3 East, M.P.M.; thence South 89 degrees 57 minutes West 2400 feet more or less; thence South 34 degrees 27 minutes West, 337 feet; thence South 21 degrees 42 minutes West, 700 feet; thence South 58 degrees 27 minutes West, 400 feet; thence South 72 degrees 37 minutes West, 2167 feet to the West line of Section 13, Township 3 South, Range 3 East.

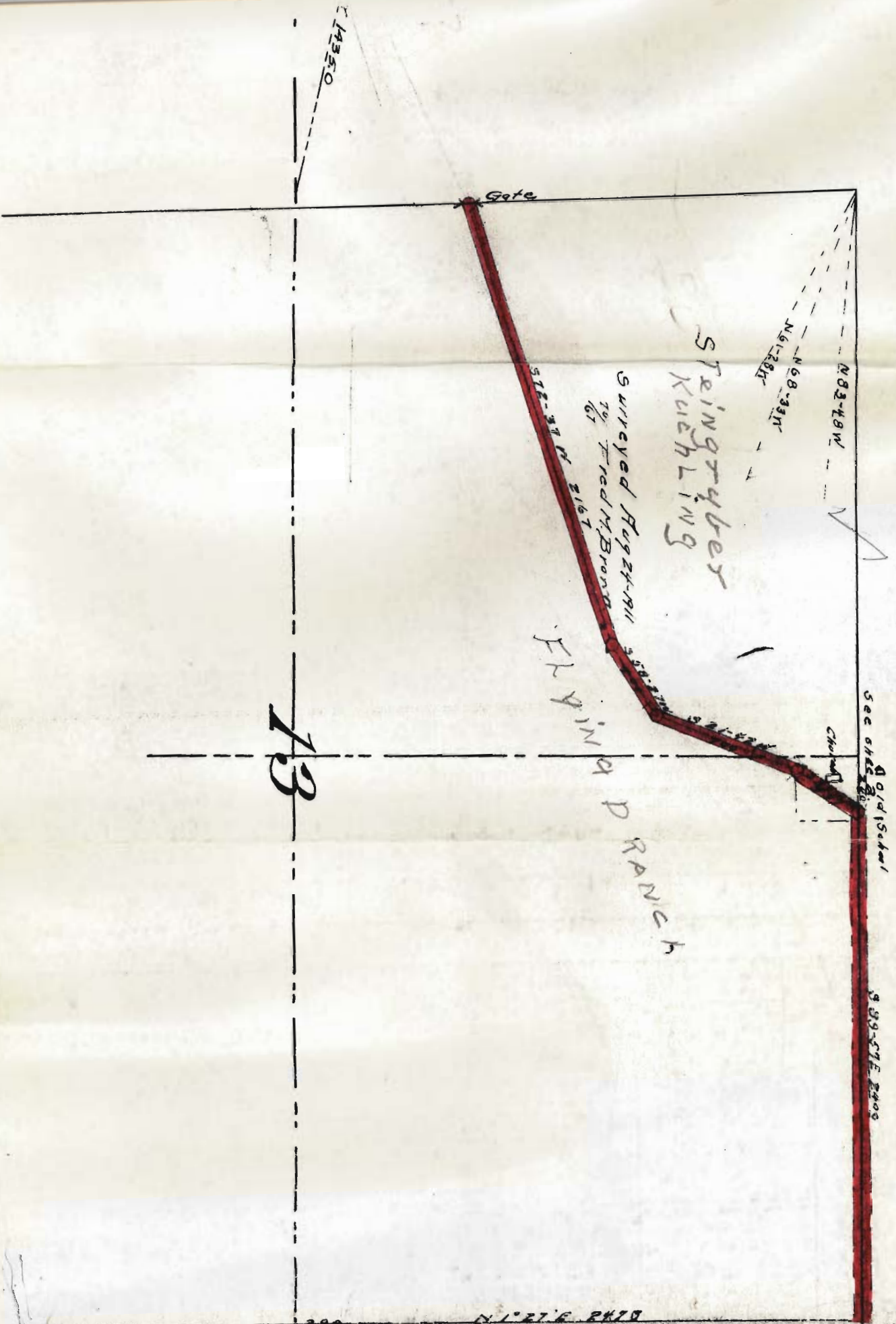

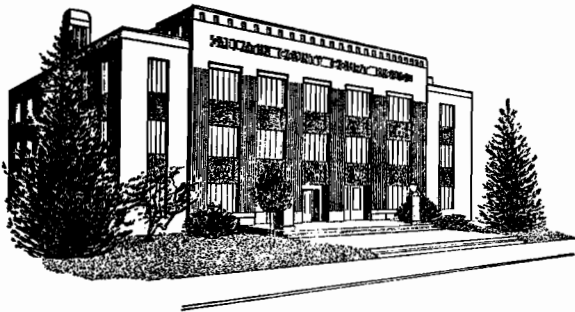



Unless a landowner or taxpayer wants to protest this petition, you are not required to attend.

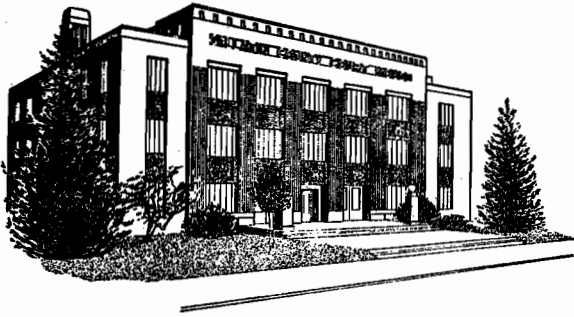
