as follows, and shown in red on the attached plat:

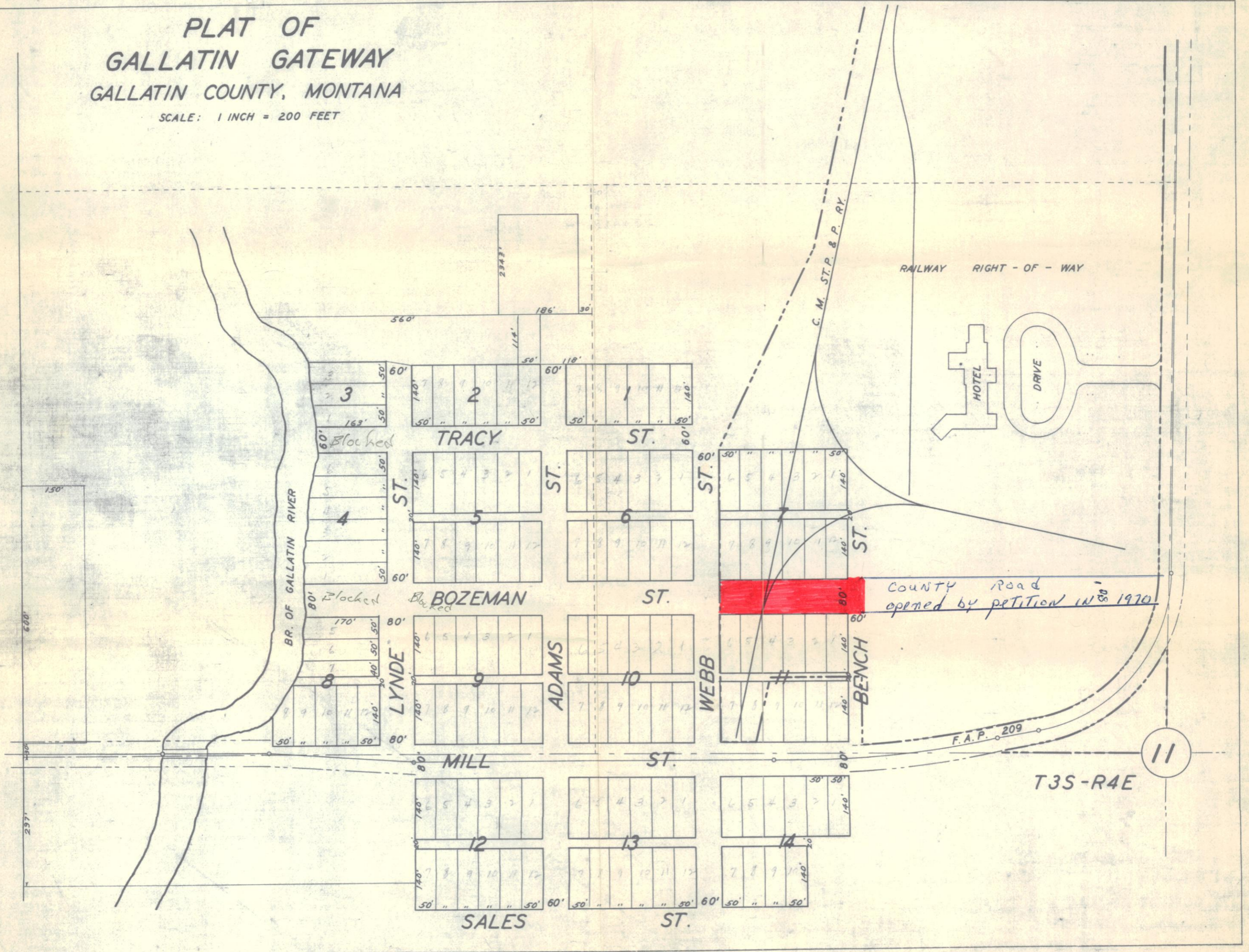
The portion of Bozeman Street that was vacated by road
