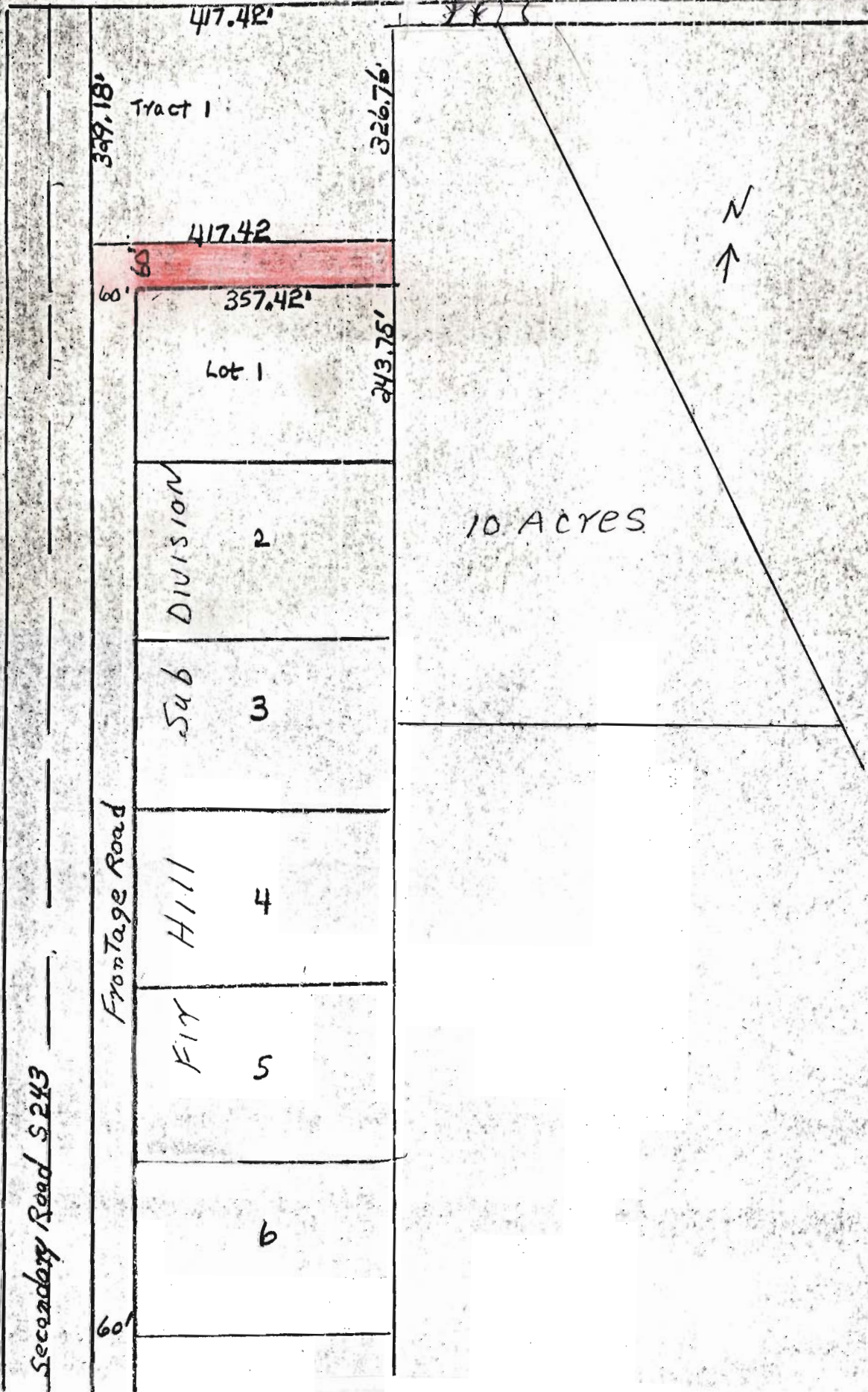
We, the undersigned freeholders of Gallatin County, Montana,

follows, and shown in red on the attached plat.

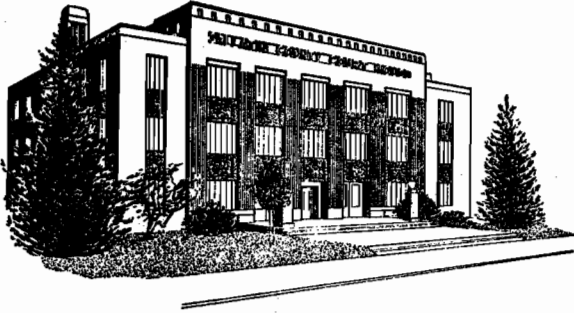
