We the undersigned Freeholders of Gallatin County, Montana taxable herein for road purposes, do hereby petition your Honorable Body to abandon the following two (2) county roads and being more particularly described as follows:

County Road #1

Starting point is 744' West of E 1/4 corner of Section 24, Township 3 North, Range 2 East; thence East 744' to the East quarter corner of Section 24; thence South 2637'; thence along section line East for 2097'; thence N. 89° 28' East for 1207'; thence N. 44° 32' East for 364'; thence S. 74° East for 1082'; thence N 75° 20' East for 440'; thence N. 28° 31' East for 511'; to end of county road.

County Road #2

This section of county road to be abandoned, begins at the NE quarter of Section 18, Township 3 South, Range 3 East; thence East 485 feet; thence South 11° East for 1100 feet; thence South 23° West for 10,159 feet to the South line of Section 19, Township 3 South, Range 3 East to the end of this county road.

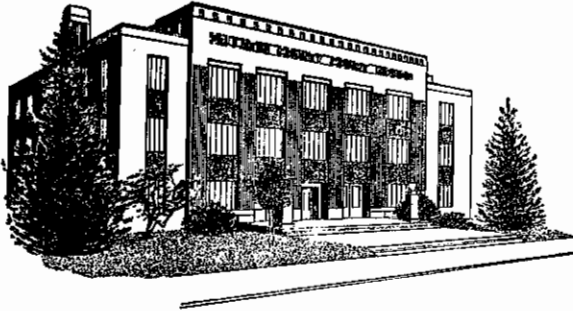



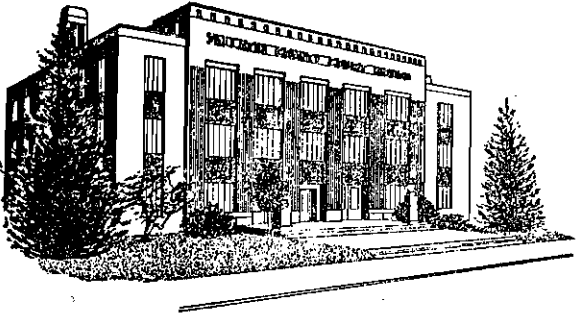

County Road #2



Dear Mr. Arnold:

Attached is a petition to abandon certain county roads in your area.

At the bottom of the steep hill as you leave the Clarkston flats is a county road that was never built. From this road there is a county road going Northeast as shown on the attached plat, which goes by your place. These two roads are shown in red.

The Board of County Commissioners realize that a portion of the road going Northeast connects two of Ponderosa Subdivision roads. Maybe you could visit with the Ponderosa people on this. When abandoned, the road reverts back to the land owners.

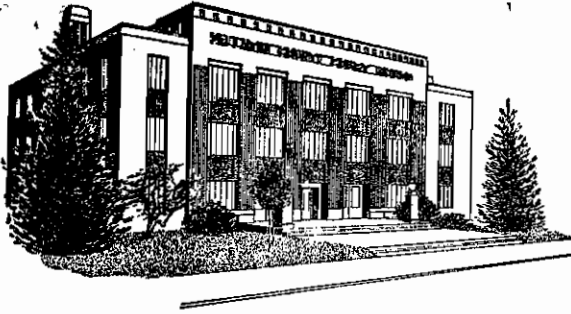
When you receive the necessary signatures, the County Commissioners will set up a hearing, at which time the Commission can abandon a certain portion and leave open the remaining County Road or they can abandon all of the roads shown in red.
