taxable herein for road purposes, do hereby petition your  
Honorable Body to abandon the following portion of County  
Road and being more particularly described as follows:

Starting point to abandon County Road is the  
South line of Section 18, Township 1 South,  
Range 1 East; thence North 20 degrees, 09'  
East for 200 feet; thence North 0 degrees 9'  
East for 560 feet; thence North 45 degrees 13'  
West for 984 feet; thence North 24 degrees  
28' West for 1200 feet; thence North 53 degrees  
40' West 140' more or less to bridge over  
Willow Creek.

Total distance 3,084 feet more or less.
